RESOLUTION NO. 9-11

A RESOLUTION OF THE SHEFFIELD LAKE CITY COUNCIL AUTHORIZING THE MAYOR AND FINANCE DIRECTOR TO ENTER INTO A CONTRACT FOR THE LEASE/PURCHASE OF THREE POLICE CARS THROUGH THE DOLLAR LEASING CORPORATION AND THE DECLARING OF AN EMERGENCY.

**WHEREAS**, it is in the best interest of the City of Sheffield Lake to enter into a lease/purchase agreement through the Dollar Leasing Corporation for three police cars; and,

**WHEREAS**, the lease/purchase of vehicles through the Dollar Leasing Corporation qualifies as a purchase of goods or services as part of State or consortium bidding; and,

**WHEREAS**, the lease/purchase of vehicles through the Dollar Leasing Corporation is exempt from the public bidding requirement of Article VIII, section 5 of the Charter of the City of Sheffield Lake; and,

**WHEREAS**, the Director of Finance has certified that the funds are available for the lease/purchase of said police cars.

**NOW, THEREFORE**, be it resolved by the Council of the City of Sheffield Lake, State of Ohio;

Section 1. The Mayor and Finance Director are hereby authorized to enter into a lease/purchase agreement, attached hereto and incorporated herein, through the Dollar Leasing Corporation for three police cars.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees which results in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 on the Ohio Revised Code.

Section 3. This Resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the

immediate necessity of entering into a lease/purchase agreement through the Dollar Leasing Corporation for three police cars.
