RESOLUTION NO. 18-11

A RESOLUTION IN SUPPORT OF THE LORAIN PUBLIC LIBRARY SYSTEM RENEWAL TAX LEVY FOR THE DOMONKAS BRANCH LIBRARY, AND THE DECLARING OF AN EMERGENCY.

WHEREAS, the Domonkas Branch Library provides free public library service to the residents of Sheffield Lake; and,

WHEREAS; the Lorain Public Library System is submitting a renewal tax levy for the May 3, 2011 ballot at a rate not to exceed two and two tenths (2.20) mills for each one hundred dollars of valuation; and,

WHEREAS, it is in the best interest of the City of Sheffield Lake to support the Lorain Public Library System renewal tax levy for the Domonkas Branch Library.

NOW THEREFORE, be it resolved by the council of the City of Sheffield Lake, County of Lorain, State of Ohio:

- Section 1. That the Sheffield Lake City Council hereby expresses its support for the Lorain Public Library System renewal tax levy for the Domonkas Branch Library.
- Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of the council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- Section 3. This Resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of the City's expression of support for the Lorain Public Library System renewal tax levy for the Domonkas Branch Library.
