RESOLUTION NO. 12-11

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE OHIO OFFICE OF CRIMINAL JUSTICE SERVICES FOR A JUSTICE ASSISTANCE GRANT AWARDED FOR LIVE SCAN IMPLEMENTATION, AND THE DECLARING OF AN EMERGENCY.

**WHEREAS**, the State of Ohio, through the Office of Criminal Justice Services (OCJS), administers financial assistance for local law enforcement through the Justice Assistance Grant; and,

**WHEREAS**, the OCJS grant award is in the amount of Ten Thousand One Hundred Thirty-Four and 00/100 Dollars (\$10,134.00) with the City of Sheffield Lake's match in the amount of One Thousand One Hundred Twenty Six and 00/100 Dollars (\$1126.00) for a total project cost of Eleven Thousand Two Hundred Sixty and 00/100 Dollars (\$11,260.00); and,

**WHEREAS**, the City of Sheffield Lake desires financial assistance through the Justice Assistance Grant for the Police Department; and,

**WHEREAS**, the Sheffield Lake Police Department wishes to be compliant with the Adam Walsh Child Protection Safety Act through the acquisition of a Live Scan fingerprinting system.

**NOW THEREFORE**, be it resolved by the council of the City of Sheffield Lake, County of Lorain, State of Ohio:

Section 1. That the Mayor is hereby authorized to enter into an Agreement with the Ohio Office of Criminal Justice Services for a Justice Assistance Grant for a Live Scan fingerprinting system.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of the council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This Resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of authorizing the Mayor to enter into an Agreement with the Ohio Office of Criminal Justice Services for the Justice Assistance Grant for a Live Scan fingerprinting system.
