ORDINANCE NO. **13-11**

AN ORDINANCE AUTHORIZING AN ADDITIONAL PAYMENT TO DON MOULD'S PLANTATION, INC. FOR THE WALKER ROAD ROADWAY AND STORM SEWER – PHASE III PROJECT, AND THE DECLARING OF AN EMERGENCY.

WHEREAS, the Council of the City of Sheffield Lake passed Ordinance No. 32-09 authorizing payment to Don Mould's Plantation, Inc. in the amount of \$351,665.50 for the reconstruction of the Walker Road Roadway and Storm Sewer – Phase III Project; and,

WHEREAS, it has been determined that this project was \$12,313.18 over the original amount due to the unanticipated cost of changing the placement of the sidewalk for safety purposes; and,

WHEREAS, it is in the best interest of the City of Sheffield Lake to authorize an additional payment to Don Mould's Plantation, Inc. in the amount of \$12,313.18.

NOW THEREFORE, be it ordained by the Council of the City of Sheffield Lake, County of Lorain, State of Ohio:

Section 1. That the Council of the City of Sheffield Lake authorizes an additional payment to Don Mould's Plantation, Inc. in the amount of Twelve Thousand Three Hundred Thirteen and 18/100 Dollars (\$12,313.18) for unanticipated change orders necessitated by the change in the placement of the sidewalk for safety purposes.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This Ordinance is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the

immediate necessity of authorizing an additional payment to Don Mould's Plantation, Inc. for the reconstruction of the Walker Road Roadway and Storm Sewer – Phase III Project.
