RESOLUTION NO. 22-11

A RESOLUTION AUTHORIZING THE CITY OF SHEFFIELD LAKE TO ACCEPT AND APPROVE THE DONATION OF KITCHEN CABINETS, COUNTER TOPS, AND MOLDING, WITH APPROXIMATE VALUE OF \$18,000.00, TO THE CITY OF SHEFFIELD LAKE TO USE IN A REFURBISHING AND REMODELING PROGRAM WHICH WILL BE ESTABLISHED AND ADMINISTERED BY THE SERVICE DIRECTOR, AND THE DECLARING OF AN EMERGENCY.

**WHEREAS**, it is the desire of Lowe’s Home Improvement Store to donate kitchen cabinets, countertops and molding, valued at approximately \$18,000.00, to the City of Sheffield Lake; and,

**WHEREAS**, it is in the best interest of the City of Sheffield Lake to accept this donation of kitchen cabinets, countertops and molding for the refurbishing and remodeling of residential homes.

**NOW, THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SHEFFIELD LAKE, STATE OF OHIO:

- Section 1. That the City of Sheffield Lake hereby accepts and approves the donation of kitchen cabinets, counter tops and molding, valued at approximately \$18,000.00, to be used in a refurbishing and remodeling program.
- Section 2. Council of the City of Sheffield Lake hereby authorizes the Service Director to establish and administer a Refurbishing and Remodeling Program for the residents of Sheffield Lake. Criteria may include but is not limited to income and flood damage.
- Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees which results in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 on the Ohio Revised Code.
- Section 4. This Resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the

immediate need to accept and approve the donation of kitchen cabinets, countertops and molding with approximate value of \$18,000.00
