RESOLUTION NO. 31-11

A RESOLUTION AUTHORIZING THE CITY OF SHEFFIELD LAKE TO ACCEPT AND APPROVE THE DONATION OF TWO PED BAGS TO THE SHEFFIELD LAKE FIRE DEPARTMENT, AND THE DECLARING OF AN EMERGENCY.

WHEREAS, it is the desire of St. John West Shore Hospital to donate two Ped Bags to the Fire Department; and,

WHEREAS, these bags will be equipped with all of the equipment and drugs needed to handle an ALS pediatric emergency; and,

WHEREAS, it is in the best interest of the City of Sheffield Lake to accept this donation of two Ped Bags from St. John West Shore Hospital .

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SHEFFIELD LAKE, STATE OF OHIO:

Section 1. That the City of Sheffield Lake hereby accepts and approves the donation of two Ped Bags, valued in the amount of \$650.00, to the Sheffield Lake Fire Department for use in an ALS pediatric emergency.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees which results in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 on the Ohio Revised Code.

Section 3. This Resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate need to accept and approve the donation of two Ped Bags to the Sheffield Lake Fire Department from St. John West Shore Hospital.
