AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH MIDDLETOWN FORD AND/OR ACCORD FINANCIAL GROUP FOR THE PURCHASE OF A FIRE DEPARTMENT UTILITY TRUCK AND THE DECLARING OF AN EMERGENCY.

WHEREAS, Accord Financial Group for Middletown Ford has provided a quote for the purchase of a fire department utility truck in the amount of Thirty-Four Thousand One Hundred Twenty-Five and 89/100 Dollars (\$34,125.89); and,

WHEREAS, the quote from Accord Financial Group for Middletown Ford is from the State Consortium Bid List and is therefore exempt from the competitive public bidding requirements of Article VIII, Section 5 of the Charter of the City of Sheffield Lake.

NOW, THEREFORE, be it ordained by the Council of the City of Sheffield Lake, State of Ohio:

- Section 1. That the Mayor is hereby authorized to enter into an agreement with Middletown Ford and/or Accord Financial (attached) for the purchase of a fire department utility truck for Thirty-Four Thousand One Hundred Twenty-Five and 89/100 Dollars (\$34,125.89).
- Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- Section 3. This ordinance is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of authorizing the Mayor to enter into an Agreement with Middletown Ford and/or Accord Financial for the purchase of a fire department utility truck.
