

RESOLUTION ADOPTING THE TENTATIVE BUDGET FOR THE CITY OF SHEFFIELD LAKE, OHIO FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2012 AND SUBMITTING THE SAME TAX BUDGET TO THE AUDITOR OF LORAIN COUNTY, SECRETARY FOR THE LORAIN COUNTY BUDGET COMMISSION AND THE DECLARING OF AN EMERGENCY.

**WHEREAS:** THE MAYOR HAS THERETOFORE PREPARED A TENTATIVE BUDGET FOR THE CITY OF SHEFFIELD LAKE, OHIO FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2012 SHOWING AT THE BEGINNING OF THE YEAR 2012

**WHEREAS:** THE COUNCIL HAS HELD A PUBLIC HEARING ON SAID BUDGET JULY 12, 2011 OF WHICH THE PUBLIC HEARING NOTICE WAS GIVEN BY PUBLICATION IN A NEWSPAPER OF GENERAL CIRCULATION.

**NOW, THEREFORE,** BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SHEFFIELD LAKE, STATE OF OHIO THAT:

- Section 1. The tax budget of the City of Sheffield Lake for the year 2012 heretofore filed in tentative form by the same is hereby adopted and the Finance Director is hereby authorized to forward two (2) copies to the Auditor of Lorain County, Ohio.
- Section 2. It is found and determined that all formal action of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of Committees which resulted in such formal action, were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- Section 3. This resolution is declared to be an emergency measure the reason being that it must be certified to the Auditor of Lorain County Budget Commission immediately. This Resolution shall take effect immediately.
