ORDINANCE NO. **38-11**

AN ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO ADVERTISE FOR BIDS FOR AND TO ENTER INTO A CONTRACT WITH THE LOWEST AND BEST BIDDER FOR THE RESURFACING OF A PORTION OF THE SHOREWAY SHOPPING CENTER PARKING LOT AND ADJACENT ENTRANCES AND THE DECLARING OF AN EMERGENCY.

WHEREAS, it is in the best interest of the City of Sheffield Lake, Ohio to advertise for bids for and to enter into a contract with the lowest and best bidder for the resurfacing of a portion of the Shoreway Shopping center parking lot and adjacent entrances.

NOW THEREFORE, be it ordained by the Council of the City of Sheffield Lake, County of Lorain, State of Ohio:

- Section 1. The Service Director is hereby authorized to advertise for and to enter into a contract with the lowest and best bidder for the resurfacing of a portion of the Shoreway Shopping center parking lot and adjacent entrances.
- Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- Section 3. This ordinance is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of advertising for bids for and entering into a contract with the resurfacing of a portion of the Shoreway Shopping center parking lot and adjacent entrances.
