RESOLUTION NO. 41-11

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SHEFFIELD LAKE REJECTING IN TOTAL THE REPORT OF FACT-FINDER AND RECOMMENDATIONS DATED AUGUST 18, 2011 PREPARED BY FACT-FINDER DONALD N. JAFFE, ESQ. IN REGARD TO THE FACT-FINDING BETWEEN THE CITY OF SHEFFIELD LAKE AND THE SHEFFIELD LAKE PROFESSIONAL FIREFIGHTERS, LOCAL 2355, IAFF, OAPFF, AFL-CIO-CLC AND THE DECLARING OF AN EMERGENCY.

WHEREAS, on May 24, 2011, June 21, 2011 and July 6, 2011 the City of Sheffield Lake and the Sheffield Lake Professional Firefighters, Local 2355, IAFF, OAPFF, AFL-CIO-CLC did engage in fact-finding (SERB case number 10-MED-06-0842), in regard to ongoing collective bargaining negotiations; and,

WHEREAS, on August 18, 2011, Fact-finder Donald N. Jaffe, Esq., did render a Report of Fact-finder and Recommendations in regard to the aforementioned proceedings; and,

WHEREAS, the City Council of the City of Sheffield Lake has had an opportunity to review said Report of Fact-finder and Recommendations.

NOW, THEREFORE, be it resolved by the City Council of the City of Sheffield Lake, State of Ohio as follows:

Section 1. The City Council of the City of Sheffield Lake hereby rejects in total the Report of Fact-finder and Recommendations dated August 18, 2011 prepared by Fact-finder Donald N. Jaffe, Esq. in regard to the fact-finding between the City of Sheffield Lake and the Sheffield Lake Professional Firefighters, Local 2355, IAFF, OAPFF, AFL-CIO-CLC, SERB case number 10-MED-10-06-0842.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such

formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This Resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate need to respond to the fact-finding report within the statutorily allotted seven days from the date of the report.
