

AN ORDINANCE PROVIDING FOR THE CURRENT EXPENDITURES AND OTHER EXPENDITURES FOR THE CITY OF SHEFFIELD LAKE, OHIO DURING THE FISCAL YEAR ENDING DECEMBER 31, 2012, AND THE DECLARING OF AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SHEFFIELD LAKE, OHIO, STATE OF OHIO THAT:

- Section 1. The Municipal budget heretofore submitted to the City Council by the Mayor is hereby adopted as the appropriation ordinance for the current expenditures for the City of Sheffield Lake, Ohio during the fiscal year ending December 31, 2012.
- Section 2. A true and correct copy of said budget is attached hereto and marked “Appendix A” and is hereby made part of this Ordinance as if it is fully set forth in the body hereby.
- Section 3. The Director of Finance of the City Sheffield Lake, Ohio is hereby authorized to draw his warrants on the City Treasury for payments from any of the foregoing appropriations upon receiving certificates and vouchers therefore asset forth in the Charter of the City of Sheffield Lake, Ohio for ordinances or resolutions of the City of Sheffield Lake, Ohio to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by the authority of and in accordance with law or ordinances. Provided further that the appropriations for contingencies can only be expended upon approval of two-thirds of Council for items be expenses constituting a legal obligation against the City and for purpose other than those covered by specific appropriations herein made.
- Section 4. It is found and determined that formal actions of this Council concerning and relating to the adoption of this Council, and that all deliberations of this Council and any of its committee which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- Section 5. This ordinance is hereby declared to be an emergency measure made necessary for the preservation of public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of adopting a municipal budget for the City of Sheffield Lake, Ohio for the fiscal year ending December 31, 2012.
