FINANCE DIRECTOR'S REPORT: Finance Director Smith advised I have just some oddball changes here as I was wanting to get a little bit of money in our equipment repairs for city hall, building repairs for city hall, bank service charges. Although 101 is a net 0 though, I have made decreases to make up the increases. PERS needs some money because we have more part-time then full-time people so I moved money there. Again, the 101 are all net 0 and the only real increase here is Shoreway operating but we have the funds to increase it but we have had to do some repairs and get some units ready to rent. Again, we are not going to necessarily going use all that \$8000.00. 209, 601 and 611 are to finish up the year, I am a little short in their postage for the monthly billing for the utility bills and I was just making sure that we had enough money through the end of the year for that. Again all of those have corresponding decreases so those are all net 0 as well. Councilman McCullough stated I thought when you say utility bills, you mean the water bills? Finance Director Smith answered yes. Councilman McCullough stated I thought that was all included with that price that we were paying that company. Finance Director Smith stated we pay between 2000 to 2200 a month and we have paid it along the way but I am going to be a little short at the end of the year to continue that on a monthly basis. It works out a lot cheaper then hiring another person that was the problem why we brought this in. Councilman McCullough stated I am thinking about it two different sides, I am doing baseball math in my head that is not right. I understand what you are saying, I am saying where is the money coming from. Forget it, duh one has nothing to do with the other one. Councilman Erdei asked how do

we look money wise for 2016 besides what the state might cut and the federal government might cut. How are we looking? Finance Director Smith answered I went to a meeting at the county a couple of weeks ago to talk about those possible cuts and they haven't gotten word yet. Yes the state would like to take the balance of our local government money but the word hasn't come down yet. Right now we
