An ordinance regulating and prohibiting the storage and/or parking of unlicensed automobiles in open areas in and throughout the Village of Sheffield Lake, Ohio. **1715**

An ordinance approving and making effective the rules and regulations, including schedules of water rates and fixed charges heretofore adopted by the Board of Trustees of Public Affairs of the Village of Sheffield Lake, Ohio on January 10, 1952. **1716**

An ordinance by the Board of Trustees of Public Affairs of this Village needs and wishes to purchase for the use of the Water Department herein a one-ton truck automobile, purchase of which Will involve an expenditure of more than \$1000.00. **1717**

An ordinance approving a schedule of water rates and authorizing the Board of Public Affairs to enter into a contract with the City of Lorain. **1718**

An ordinance to make appropriations for current expenditures and other expenditures of the Village of Sheffield Lake, State of Ohio during the fiscal year ending December 31st, 1952. **1719**

An ordinance to amend ordinance no. 1537 respecting construction of the Lake Road main sewer and declaring of an emergency. **1720**

A resolution determining that this municipal corporation has a Police automobile which is unfit for public use, and that said

corporation has need of another vehicle to replace the same, and resolving to sell said present police vehicle and to purchase a substitute vehicle therefor. **1721**

An ordinance authorizing the Mayor and Clerk of the Village of Sheffield Lake, Ohio to enter into a contract for the collection of garbage for a period of one year beginning with April 15, 1952. **1722**

A resolution authorizing this Council has heretofore entered into a contract with John A Petsche, Engineer for the performing of services in connection with the construction of the Lake Road Truck Sewers and all of the steps incidental thereto. **1723**

An ordinance amending ordinance no. 1087 and adopting a new schedule of fees and charges for license fees and construction permits. **1724**

A resolution to proceed to advertise for oil for oiling of streets not to exceed 15,000 gallons. **1725**

A resolution accepting a bid for the purchase of one new police car from the Williams Ford, Inc. Company for the use of the Police Department of the Village and of crediting such bid a bid for the purchase from said Village of a presently owned police car which is unfit for public use. **1726**

A resolution of the Highway Department of the State of Ohio has proposed that Ohio State Route No. 2, otherwise known as US Route No. 6, and as Lake Road extends easterly and westerly in and through the entire limits of Sheffield Lake Village Ohio. **1727**

A resolution authorizing the Solicitor and special Council to proceed with the defense of this Village in case no. in the Supreme Court of Ohio and authorizing the expenditure of not more than \$150.00 for printing of briefs in said cause. **1728**

A resolution estimating the active funds to be awarded and deposited for a period of two (2) years from June 10, 1952 to June 10, 1954 and fixing the date for the designation of

depositories. **1729**

An ordinance approving and making effective the rules and regulations, including schedules of water rates and fixed charges heretofore adopted by the Board of Trustees of Public Affairs of the Village of Sheffield Lake, Ohio on January 22, 1952. **1730**

A resolution that this Council has heretofore entered into a contract with John A. Petsche, Engineer for the performance of services in connection with the Lake Road main trunk sewer and all other steps pertinent thereto. **1731**

A resolution for the gas mains now existing in Sheffield Lake now extend service to only a small portion of said Village. **1732**

A resolution authorizing the council of Village of Sheffield Lake, Ohio to grant paid vacations to all full-time employees of said Village. **1733**

- An ordinance amending section 83 (a) of Chapter 6 of ordinance no. 1087, and establishing new standards for the construction of chimneys. **1741**

- A resolution directing the owner of certain lots and lands within this Village to drain the same and to clear and remove obstructions from all drainage ditches passing through, across or along said lots and lands. **1742**

- A resolution granting paid vacations to all permanent employees of the Village of Sheffield Lake, Ohio. **1744**

- A resolution authorizing the Mayor, Solicitor and special counsel to compromise and abate a certain finding in favor of the Village of Sheffield Lake against Mosser Construction, Inc., and to settle and conclude litigation now pending between said Mosser Construction, Inc., and said Village resulting from abrogation and/or non-performance of certain contracts previously existing between said Mosser Construction Inc., and this Village, and appropriating money for and directing payment of the amounts set forth in said compromise and settlement. **1745**
