An ordinance amending ordinance no. 1714, passed by the Council of the Village of Sheffield Lake, Ohio on the 8th day of January 1952 and setting up new and increased salaries for the Chief of Police, the Fire Department Driver, Assistant Chief of the Fire Department, Captain of the Fire Department and Lieutenant of the Fire Department. **1759**

An ordinance making appropriations for current expenses and other expenditures of the Village of Sheffield Lake, State of Ohio during the fiscal year ending December 31, 1953. **1760**
