An ordinance creating the office of Village Forester; providing for the planting, care and removal of trees and shrubs in the public streets, parkways and other public areas of the Village of Sheffield Lake, Ohio; and prescribing a penalty for violation hereof.

An ordinance to amend the Sheffield Lake sanitary sewer specifications.

21-60

A resolution accepting the dedication for public use of the water main, storm sewers, sanitary sewers and appurtenances in Erieview Boulevard in the Westview Estates subdivision in the Village of Sheffield Lake, Ohio.

22-60

A resolution declaring it necessary to improve certain streets in the Padaway Allotment and the second, third and fourth additions thereto in the Village of Sheffield Lake, Ohio by repaving and draining, and constructing curbing, catch basins, curb drains and other drainage facilities where necessary, together with appurtenances thereto and declaring an emergency.

An ordinance regulating the control and operation of watercraft upon any and all navigable waters within the municipality of Sheffield Lake, Ohio and the declaring of an emergency.

A resolution amending resolution 79-59 which declared it necessary to improve Parkview Drive and portions of Parkway Drive, Hawthorne Avenue, Richelieu Avenue, Ivanhoe Avenue, Madison Avenue and Ferndale Avenue

in the Village of Sheffield Lake, Ohio by installing storm and sanitary sewers, water main, and sewer and water curb connections where necessary, together with the necessary outfall storm sewer from the intersection of Parkview Drive and the southerly line of Lake Road northerly across Lake Road, and thence northerly approximately 400 feet to Lake Erie. **25-60**

A resolution amending resolution no. 81-59 which declared it necessary to improve Elm Street and portions of Hawthorne Avenue, Madison Avenue and Richelieu Avenue in the Village of Sheffield Lake, Ohio, by installing storm and sanitary sewers and water main and sewer and water curb connections where necessary together with the necessary appurtenances thereto, and necessary outfall storm sewer. **26-60**

A resolution declaring it necessary to improve Pasadena Avenue and Hawthorne Avenue in the Village of Sheffield Lake, Ohio, by constructing an outlet trunk sewer in Sunset Avenue together with necessary appurtenances thereto, and declaring an emergency. **27-60**

An ordinance to provide for the issuance of a note in anticipation of the collection of current expenses and declaring of an emergency. **28-60**

An ordinance to vacate portions of Parkview Drive in the Village of Sheffield Lake, Ohio. **29-60**

A resolution declaring it necessary to improve portions of Parkview Drive, Parkway Drive, Hawthorne Avenue and Elm Street in the Village of Sheffield Lake, Ohio, by installing storm and sanitary sewers, water main, and sewer and water curb connections where necessary,

together with the necessary outfall storm sewer from the intersection of Parkview Drive and the southerly line of Lake Road northerly across Lake Road, and thence northerly approximately 400 feet to Lake Erie.

30-60

A resolution declaring it necessary to clean and improve Rothgery Ditch from the southerly boundary of the Village of Sheffield Lake to the south of side of Lake Road in the Village of Sheffield Lake, Ohio and the declaring of an emergency.

31-60

An ordinance to provide for the issuance of a note in anticipation of the levy of special assessments and in anticipation of the issuance of bonds to pay the property owners and the city's portions of the cost of improving Irving Park Boulevard, Madison Avenue
