

## 1989 ORDINANCES AND RESOLUTIONS

### Ord/Res#

An ordinance authorizing the City of Sheffield Lake, Ohio, to pay to the Tri-City office on Aging the sum of \$2250.00 to be applied towards the cost of insurance to be purchased by the Tri-City Office on Aging from the lowest and best bidder, and the declaring of an emergency.

**1-89**

A resolution for the submission to the electors of the City of Sheffield Lake, Ohio, an ordinance amending ordinance 61-68 and by so doing reducing the tax credit allowed pursuant to section no. 15 of that ordinance from fifty percent (50%) to forty-five percent (45%) for the purpose of paying for and maintaining a boat launch and fishing pier facility within the City of Sheffield Lake, Ohio.

authorize the payment of additional premiums for increased liability coverage general liability insurance and automotive liability insurance for the City of Sheffield Lake, Ohio, from \$500,000.00 to one million dollars with personal insurance company, and the declaring of an emergency. **6-89**

An ordinance authorizing the Mayor to advertise for bids for and to enter into a contract(s) with the lowest and best bidder for the city's insurance policies and the declaring of an emergency. **7-89**

An ordinance approving the editing and inclusion of certain ordinances as parts of the various component codes of the codified ordinances of Sheffield Lake, Ohio, and the declaring of an emergency. **8-89**

An ordinance repealing codified ordinance no. 129.06 of the codified ordinances of the City of Sheffield Lake, Ohio, relating to revenue sharing. **9-89**

An ordinance amending Chapter 533 of the codified ordinances of the City of Sheffield Lake, Ohio, by adding certain definitions and by prohibiting child pornography, the unlawful display of materials harmful to juveniles, the unlawful exposure by waiters, waitresses and entertainers and prohibiting certain other acts relating to those offenses, and the declaring of an emergency. **10-89**

A resolution declaring it necessary to improve Oakwood Avenue, Sunset Avenue and Alameda Avenue by constructing storm sewers and all necessary appurtenances, and declaring an emergency. **11-89**

An ordinance providing for an increase in appropriations within the ninety-day appropriations ordinance for the City of Sheffield Lake, Ohio. **12-89**

An ordinance authorizing Charles H Kelly, Mayor, and Donald L Smith, President of Council, to be authorized signatores in their official capacities on the Sheffield Lake, Ohio, Mayor's Court account with the Central Trust Company, and the declaring of an emergency. **29-89**

An ordinance authorizing a renewal for one year of the \$45,050.00 note from the sewer capital fund no. 1, 710-050, to the Sunset, Oakwood and Alameda storm sewer fund at an interest rate of 5.7%, and the declaring of an emergency. **30-89**
