will let everybody know that the electric ground vault at Shoreway is repaired and the electrician is now currently working on the parking lot lights ballast and lamps. The temporary part-time employee replacement for John McCallie is working out most favorably, everything is going good. I did contact Joe Muddray at Clearwire; he represents the carrier that is going to be going on the water tower – just to get a current upgrade and status. It is on hold for a few months, it is not canceled or anything and he stressed that. It is just on hold while they go through a couple of economic rearrangements that they are doing internally within the company. I just wanted to bring that to your attention. \*Motion by Huska/Second by Bring to accept the report. Yeas All./**LAW DIRECTORS REPORT: None.**

**Grant Administrator William Gardner** advised you have before you I think 4 pieces of legislation that the Law Director made up and they are actually redundant of one another but it is because they are 2 different grants with the same amount of money. The state can award them either or/or both but only up to the amount that we ask for which would be \$77,500 on the one for the bike trail that connects the bottom end of the Ferndale to the Lorain Metro Parks that is going to be going in on Harris Road. The other grant for \$37,500 I believe and that is for the bathroom at the Boat Launch which would be the head of the trail bathroom and that is the third time that we have put in for that. The city's portion I think is \$14,500 on that and the city's portion on the other one is \$20 something—it is \$110,000 less the \$77,500 so it would be \$32,500. It is very competitive, I am not sure we will get either or any of them but at least we are going to be putting them in and they are due on the first of February. Finance Director Smith advised I just wanted to bring to everybody's attention I forgot and I was thinking Dave was going to be here, we have a resolution for a donation from Amvets and VFW for a camera. There is a mandate HB77 which mandates us to video-tape any interviews in booking and we were looking for hopefully somebody was going to donate to give us that equipment and they are actually splitting the costs between them and the total costs is \$1895.00 and we should have the money by the end of the week but I wanted to get this resolution to you so we could approve that donation. President Podmanik advised it appears that the resolutions that Mr. Gardner discussed with regards to the grants of Council#5, 6, 7 and 8. The resolution that Finance Director Smith has brought forward to discuss is Council#9. Let's start with the first 4 that Mr. Gardner brought forth. Councilman Bring asked the money that we have to match out of that if we get those, would that come out of this year's budget? Finance Director Smith answered is it a grant for this year? Grant Administrator Gardner answered yes it is this year's grant, it would be late in the year though. Councilman Bring asked where is it going to come from? Grant Administrator Gardner answered general fund. Finance Director Smith added we would probably have further discussion on that if we get the grants, my thought is that we have a note

that we have a note that we can piggy-back on and possibly work with that to find the money. Councilman Rosso stated just so that I am crystal clear on this, what we are talking about now is applying for these grants and say we get it and through discussions for whatever reason we couldn't come up with matching funds – we could technically refuse the grant at that point right? Grant Administrator Gardner and Finance Director Smith answered yes. Finance Director Smith added that is why I am not really concerned about it at this point. Councilman Rosso stated which is what I am trying in my mind make sure that we are not committing \$50,000 or whatever it adds up to tonight without looking through it. Finance Director Smith stated it is more like \$30,000 too. Councilman Bring advised \$32,500. Grant Writer Gardner answered it would be close to \$50,000 if we got both of them. Councilman Rosso asked the bike trail goes from where to where. Grant Writer Gardner answered it goes from Ferndale Park to the new Metro Parks which goes along the extension of Oster Road into across Idlewood and goes into the woods at Idlewood – the woods in the Village at Idlewood and that is the new Metro Parks Nature Preserve and they are going to have a trail that goes through it to Harris Road and connect to the safe routes to school. Councilman Rosso clarified so this pretty much goes from Ferndale Park; the south end of it – east to Idlewood and then to the woods which is what 2 or 3 blocks from Ferndale Park to Idlewood? I thought it was cutting over at that point into the Village, it is going all the way to Oster? Grant Writer Gardner answered Idlewood is where it enters the Village. Service Director Smith advised it is not 2 or 3 blocks Rick, it is like 4 streets I believe off the top of my head. Grant Writer Gardner stated it is 1200 feet from the right-of-way of Oster/Forestlawn extension to Idlewood – 1200 feet. Then it is from that point north to where it intersects the trail – the circular part of the park is 30 feet and then there is a connection across from Allen Court to Rowelyn that is about 210 feet so that is all part of that trail. Councilman Rosso stated just 1700 or 1800 feet. Grant Administrator Gardner answered yes or something like that. Councilman Rosso explained Len you are probably right in my mind I was thinking the park and then there was Grantwood and then Idlewood – that is why I came up with 2 blocks but there is probably streets between these. Service Director Smith stated it runs south through the backside of Allen Court to Ferndale across through the woods on the south end – across onto the ditch area, the ditch area eastward to the corner of that ditch and Idlewood on the southeast corner is where it is going to intersect the Metro Parks trail. Councilman Rosso advised Bill really answered how many feet it was, in my mind it seemed like it was just a real short distance but 1800 feet is a lot farther. President Podmanik asked is there a penalty should we have to refuse these grants later on down the road, what harm does that cause us. Grant Administrator Gardner answered it is not against the law to refuse them. President Podmanik asked doesn't that put us in a bad light with the people

that we are applying to? Grant Administrator Gardner answered there will be plenty of people that want it, I can tell you that. President Podmanik stated I understand that but doesn't that put us in a bad light with those who grant us the money? It seems to me at one time I remember a few years back that we had an issue about what would happen for returning money. Grant Administrator Gardner answered under Issue II it made a difference; this is (ODNR) Ohio Department of Natural Resources that is supporting these grants. President Podmanik asked so if we don't use it – no harm, no foul; we can send it back basically? Grant Administrator Gardner answered I don't believe there is any consequence to it, none that I know of and it doesn't so in the grant.

***CITIZENS COMMENTARY:***

***Kerry McCullough, 685 Roberts St.*** stated Bill I can't get my mind around this, where is the Village going to come into Sheffield Lake at –right along Idlewood? Grant Administrator Gardner answered the east side of Idlewood is Sheffield Lake but it only goes about from me to Tammy and then it is the Village and that is where the park is. It is going to go to the park and then internally within the park there is going to be a trail in the park that comes out on Harris Road and Harris Road is where it intersects the safe routes to bike trail. Mr. McCullough advised I had forgot - thanks. He continued I guess the question that I have then about what you are putting in at the boat launch but is there any way that you could and I know that it is late for this but why not have something up there that somebody could lease from the city such as a bait shop? Put up a building and then somebody just Lorain did with the "Roles Café" (unknown spelling) or whatever it is, only not that big but why couldn't we have a building up there that can – very small, have 2 restrooms in it – that way they are always being watched by somebody who is running a small business. You can get pop and ice and worms or minnows or whatever out of the bait shop. I guess what I am saying is why are we just putting 1 building for toilets, it doesn't make any sense that we would only put up 1 building for toilets when we are not charging for the boat launch now, why not try to figure out a way to make money up there. Now we are just pouring more money into the boat launch. I guess that is my question for Council and my question for everybody, why aren't we looking at this as a bigger picture thing rather than just putting up toilets because I know at one point you wanted to have a flat screen up there and all this other stuff and it sounded great but we don't have the \$14,000.00 to match a grant. If we don't have a way out of it, if you can rent the place for I don't know say \$10,000.00 a summer then over a period of time it pays off, you can't rent just bathrooms you are going to have to rent something else with it. If you look at the big picture of the thing and like I said it might be too late and you might have to do it in a phase but is there plans done and who is also going to maintain those restrooms. It is going to be our parks department that is going to put

more of a burden on our city that we are going to have to pay the guys to go in there and clean them. They are paid to cut grass, not clean toilets. It is just my thought, you guys are going to do what you are going to do but it is my thought behind those. If we are not looking at things big picture, we are just looking at one little thing. As far as the bike trail, it just sounds like a lot of money for a little bit of area but I know things are expensive. Grant Administrator Gardner advised I just wanted to say that one of the reasons we would get this bathroom is because it is the bike trail head and the rest area on the scenic Ohio bikeway and it connects to 611 which goes into Day Park which would give it a terminal point. Otherwise we probably wouldn't qualify but we are on the national identified bike trail there on Lake Road and we are on with 611 with the state trail and it makes a connection that goes conceivably all the way to Kipton which is an advantage for us.

Otherwise we don't have to build it if you don't want to. Mr. McCullough asked are you talking about the bike trail or are you talking about the restroom? Grant Administrator Gardner answered the restroom is on the bike trail in theory, that is the reason. Mr. McCullough stated I guess then what I am saying is that all the more reason is you need to look at having some type of retail establishment at there because how many times do you see people riding down Lake Road in the summer time and you know they are coming from forever because they have backpacks on them and they know that that rest-stop is going to be there with a toilet. That is all the more reason to have some type of small retail establishment there. We have park benches there; they can buy ice cream or whatever and citizens could walk up and buy pushups or popsicles or just something cheap but I see it as a big opportunity if you are going to do something like that. I mean if you are going to do something like that then you need to look at the overall big picture rather than just a restroom that is just going to be another expense. We need to push the expense off of us and onto somebody else.

**Debbie Belaska, 4014 E Lake Rd.**, stated Bill you did a wonderful job, I really enjoyed myself today and I am glad I participated in that grant that you did with the exercising. You did a lot for me and I want to thank you and you did a nice job with the food and I appreciate it. Councilman Rosso asked I guess this might be to Steve or to Len on the bathroom at the park, obviously that goes through Park Board but I guess my perception is that this is still kind of at a real high level phase. You guys haven't or have you discussed like hey here is kind of the plans or here is definitely want to build it? Service Director Smith answered it has always been in the plans. You got to remember that these grants are structured for what they are at the time and who offers them. We phased that grant and ODNR limited what we could go after with all their restrictions and the hoops that they made us jump Kerry and I think that you are aware of them. They require certain things for each grant and then they say and this is not to argue with you. This is a point for

everyone to understand, the methodology that they use in the process of each grant. Like for instance, that grant might not cover – our boat launch grant didn't cover restrooms; they refused to put restrooms in on the first phase of the boat launch. Why? What was one of their criteria, Bill if you would explain how at least if we are going to make this point or whatever it is a fact that ODNR determines what requirements a grant has. If a grant is for these certain things – they give you a list of what you can apply for. If you want to add things beyond that then you are paying out of pocket for it. You are paying full price for anything that you are going to add above and beyond what the grant is actually for. So I think that in this situation, you always planned as members of the Park Board previously on getting restrooms up there for the boaters and people that use the park – that was the plan. This is the same grant that we have applied for how many times? Grant Administrator Gardner answered this is the third time. Service Director Smith advised this is the third time then it is up to you guys. If you don't want to apply for it then that is fine. Councilman Rosso stated not that you didn't at some point have a goal that we wanted restrooms up at that boat launch. I am not saying that we never wanted that, hey do you like where the building would be located, the size of the building and things like that. Service Director Smith answered we had thought ahead during construction phase and Bill can explain to you that we had sewer and amenities put in the ground. Councilman Rosso stated okay so you had a spot already then. Grant Administrator Gardner advised it is already sewer, water and the wind turbines are part of the electrical system that will power it. That will be the primary source of power for the bathrooms. Councilman Rosso asked it wouldn't take anything away from the parking area right? Grant Administrator Gardner answered no it is down, you know where the stand-up for the electric is? Councilman Kovach advised you know where the docks are at right now, it is in that area there next to the library and it is easily accessible to when they would be loading their boats in that loading area and nowhere near the parking lot. Service Director Smith advised it is purely up to you guys what direction you want to go in. Councilman Rosso stated I was curious how far you planned ahead and where it was actually supposed to be. Mr. McCullough stated I am only going off of what I have been told and what you just said. You just said and I am not trying to argue or anything so hear me when I am saying and what I am going off of and you just reiterated it. You said the first part of that boat launch they weren't paying for phase I and had no restrooms, no nothing it was only the boat launch – that is what it was. Service Director Smith stated that is what the requirements were at that time which we applied to 4 times. Mr. McCullough continued okay but you just told me and what I knew and this is what I have been told before that you already have electrical stuff in, sewer stuff in, amenities stuff in. Were you or weren't you allowed to do that or was that something we already paid for? What I am saying is

if we have it there and we are going to get this money then why aren't we looking at the big picture and saying alright how much is it going to cost to put a small 200 – 400 foot room in there with a couple of coolers. Service Director Smith stated the original grant actually had a full length building in the cliff, sunken into the cliff with a glass side Kerry and they said no that can't be part of the grant. This is what I am trying to tell you without causing an argument. The grant that Bill is going after is exclusive to the restrooms. If the city wants to take that project on that is great, let the city take it on. Mr. McCullough stated that is not what I am asking you, I am asking is there a plan when you put this together that now you can't add a building to that? You get this grant and you can't move forward and say okay now we are going to put in this and we are going to leave this out? Service Director Smith answered there are a lot of things that change, year after year, application process after application process. Finance Director Smith stated I get what you are saying Kerry, once ODNR we do the project, if we did put in the bathroom just per say – after that we could probably. Grant Administrator Gardner advised the bathroom is a concrete lifted put-in place bathroom that is done by a Norwalk concrete company – it is total and it will come in there, we build a footer under it and we sit it right down and we already have sewer, water and electric there. It will connect right there and be done but it is a solid one-piece and it does have a outside faucet for use by the boaters when they want to use it for water or something like that. It has 2 separate handicap bathrooms. President Podmanik stated Kerry what you basically wanting to know is can we put an addition on the bathrooms? Mr. McCullough stated no you can't. President Podmanik asked is that what you are asking? Mr. McCullough answered yes but no you can't. Grant Administrator Gardner advised there isn't enough room on the side where the bathroom is set up to put one without taking away parking lot and that is the off-ramp parking lot/stopping for the boats in order to tarp and stuff like that so there is really no space there to put anything. If you were going to put one I don't have any problem with doing it across the street or wherever you want to do it but there really isn't a spot there unless you tear down the library and put one there or use the library for that but that is the only place it is going to go. Or like Lenny said we were talking about putting it into the bank. Mr. McCullough stated I just hope that there is enough planning done ahead so that when a kid runs out the door they are running into the library rather than out into traffic with those boats coming up the ramp. Grant Administrator Gardner advised there is a barrier on the sidewalk right there.

**Mark J Erdei, 4015 Tennyson** stated we haven't heard no news on Shoreway Shopping Center, anybody interested – tenants or anything? Is there anybody looking at what is left vacant in the existing one now? Mayor Piskura advised there is a firm out of Avon Lake that has showed some interest, a couple of leads that we

had and they were pretty serious leads backed out I want to say in December. Other than that there hasn't been much activity. Mr. Erdei asked on the purchase of the shopping center, I know we are in some kind of negotiations with Levin Trust or whatever about the contents of the bowling alley. I mean did somebody not do their homework and really look over that sale or purchase agreement or whatever and stipulated that okay we will buy everything but you want the bowling alley and that is what we are fighting over right now right? Mayor Piskura answered no, actually in the purchase agreement that is one of the items that we agreed to is his ability to go after back rent and he had already filed and won an attachment for the business property that was inside of the bowling alley. So what they intended to do was to take the business property out of the bowling alley, sale it at auction and then recoup at least a portion of the back rent that the previous tenant owed them. That is what we have been discussing and what is in court is what is "business property" because the lanes for instance – is that a fixture or is that business property that can be removed from the building. The balls and the lockers and the tables and the scoring machines – that kind of thing is a little bit more clear but what they are discussing is what is going to be considered business property. That is one of the things that we did agree to when we bought it. So we still own the land and we still own the building, it would be the same thing if any other business decided that they could no longer operate. The contents that belongs to them still belongs to them, we don't have a right to that property. Mr. Erdei asked so now is this hopefully not drag on – if he wants to take the alleys out of there then take them out of there and we can put in like a kids rec center or something just to keep that building going? Mayor Piskura answered well it actually would have been over already but Chase Bank weighed in because evidently there was an outstanding lien on the business property from Chase Bank from some loan that they took out 5 years ago or something like that and they are the first place holders. So Chase came forward in the court case wanting to assert their claim as well. So now Chase and Levin and the city are all trying to work it out but had it not been for Chase coming to the table it would have been done already.

**Debbie Belaska, 4014 E Lake** asked Mayor, Bob Eberschweller wanted me to ask you a question as he can't get down here because of the ice and that and he is afraid to slip in that. He wants to know about the minutes that were posted on the website, will you bring back up the archives of them so he doesn't have to come down here and get the minutes. That he can actually see them on the website. Mayor Piskura answered that portion of the website is under the direct control of the Clerk of Council. President Podmanik asked Clerk Fantauzzi are you still having trouble with that? Clerk Fantauzzi answered yes. President Podmanik advised Mayor Piskura you are aware she is having some trouble with that. Mayor Piskura answered no. Clerk Fantauzzi advised I am working with Matt



(webmaster) and he is working on it. Mr. McCullough advised I can attest to the fact that if you write her and ask for the minutes she will send them to you. President Podmanik advised if you give her your email address she will also send you schedules. Mrs. Belaska stated she does an awesome job.

**UNFINISHED BUSINESS:** Councilwoman Stark asked can you give us an update on the internet cafes. The one on the corner of Harris said they were opening soon and the one at Pizza Hut. Service Director Smith advised the second license was issue last week and that is for the old Schuenenman's, he met all the criteria and paid his fees. The third one which is in Pizza Hut is still working on interior issues and has not gotten her machines yet. I talked to her about a week and a half ago when I gave the update and I contacted her and she said everything was going fine so expect her within a couple of weeks. The fourth one, the last inquiry or the last application that was pulled, I haven't heard anything from them. I called their attorney who was representing them to try to get an update and he had just said that they were taking off for the holidays. He had no information and he said that if there was going to be a change he would let me know but I still have not heard from him. **NEW BUSINESS:** \*Motion by Huska/Second by Elliott to amend the agenda to include Council#005, 006, 007, 008 and 009.
