**DIRECTOR:** Service Director Smith stated I am going to refer to the minutes of the Roads & Drains Committee for everybody in the audience. We had a detailed review of things that are going on and that was last night that those minutes were put together in that short period of time but it does reflect the discussions that we have had and the things that are up to date. I will give a brief synopsis, Dennis has already covered it – the amount of rain that we had, totally inundated not only Sheffield Lake but Avon Lake, Sheffield Village, Lorain; every city in Lorain County. Efforts are underway to extend the disaster relief offered or applied through the Federal Government as Fire Chief Card has said through Lorain County EMA. I would like to ask that anybody who hasn't already done so, I believe almost everybody that is here that I recognize is already on the list. We are keeping a list too at the Service Department of basements that were flooded and the type of damage, etc. and I ask that they call 949-6259 and we will get that information and a compilation of all the results will go back to Mr. Card and Mr. Card will take care of that getting to EMA. We are currently doing an assessment of many of the major sanitary throughout the city, the ones that had more of a failure than the other ditches, storm sewers; anything throughout the city involving surface drainage and sanitary drainage. We are moving at a really fast clip/as best as we possibly can under the circumstances. The lawn waste dumpster – I wanted to bring up as it has been moved to the back of the Service Department and is only available during normal business hours. We had people who seemed to every weekend decide they wanted to fill it up with garbage, trash and carpet; instead of the branches that it is there for. It is just to the point where it has to be policed, so we now have limited hours on that free dumpster and it will be only during the normal business hours of the Water Department and it is under camera. \*Motion by Huska/Second by Bring to accept the report. Yeas All.

**LAW DIRECTORS REPORT:** Law Director Graves reported negotiations are on-going with the IAFF and the Fire Department union. We are discussing dates to go to fact finding and I will keep Council apprised of that. We also have a tentative settlement between work done regarding the Bowling Alley and I will be bringing that legislation to Council soon. Also I think I am having a meeting tomorrow with the Service Director and some other employees over there to put the final review for our updates of our stormwater ordinances that we need to update which I have discussed in the past and I think I will be bringing those to Council in the very near future. He reviewed the legislation for tonight that has been talked about a little bit. \*Motion by Huska/Second by Bring to accept the report. Yeas All.

**CITIZENS COMMENTARY:**

**Dave Engle, 4880 Madison** asked is there forms for residents to fill out that got water damage and possibly recoup. Service Director Smith advised no there is

nothing to do with liability, the reason for reporting the damages is that the County is applying on a master level for funds that could be available possibly for loans or some type of programs through the Federal government – FEMA, HUD, through different things when there is a catastrophe like this. The dollar amounts of the estimated damage and the number of residents that are affected go into a formula that they figure out and that determines where the need is and if we qualify. I don't know the methodology of those demographics but it is just something that we are doing as we are trying to get as many possible reports of flooding issues at least on paper. But it is not a liability issue, we don't have that opened up yet and that is going to be done through the county. I think I had as of yesterday or today now it is 40 some flooding homes, I know there probably has to be at least twice that many if not 140 that I am estimating approximately within the city. As I keep getting information, I keep writing it down and we keep logging it. I had a nice conversation today with the newspaper about getting the word out for people to call, just like Fire Chief Card tried to say – get the information out to people to at least call and document the information so we have it and we can get it there. We have until April 3<sup>rd</sup> to do that. Mr. Engle advised this is the second time our street has flooded in 3 years and I mean it was from one side of the street to the other side of the street. What I get out of this issue is there has been water problems down Treadway that is kind of got down to our street on Madison. We didn't know but after all these big rains, we are getting hit there bad and something needs to be done as people's properties are getting damaged and folks are missing work. I know we got a lot of rain but it is not a good thing. Councilman Bring stated that was one of the roads that we did discuss last night. Service Director Smith concurred that was one of the roads that we discussed and I believe that Mr. Engle is aware that I am looking into it. As I decided yesterday with you guys and explained there are issues with ditches from Lafayette to Treadway to Hawthorne that have been filled in and had other issues. Last night I named a lot of stuff that we were working on, it is still not a complete list of all the different areas we are doing and like I explicitly explained to the group of residents that are here I am not in the business of making accusations, I am in the business of understanding what is going wrong and how to fix and correct it and then move forward and then we can turn around and look at it. But there are other issues involving drainages, it is not just your area specific. We have families that are misplaced, they are actually moved out of their houses over on Kenilworth because of water levels that were extremely high. We have people on Holl whose basements were totally inundated with water and they had their living space or split level part of their houses was totally flooded. So it is not just one area of the city it is a whole group of areas within the city and we are trying to look at them as best as we possibly can. Mr. Engle stated Mr. Smith came out and I got to give him a hand for that. He has been on the job for 10 months he told us and he really got to work on this thing and he is

really looking into it. So us residents we just want it taken care of, my van was out on the street 3 years ago and there was water inside of that. Luckily it wasn't on the street this time because it would have been flooded out. I don't know if any other folks did on the street but I know these folks here, they were right on the corner and they got the blunt of all of it. They got 5 kids, water went inside and a couple of years ago I think the city came down there and they kind of cut something in with a backhoe and you probably wasn't aware of this but some residents are having some problems on Treadway and this still comes back to 3 or 4 years ago of whatever was done upstream and we are still getting the blunt of it. So until whatever is taken care of, we will probably still continue to get flooded when we get big rains and the end of winter is like this. Councilman Bring advised we got another one coming tomorrow. Also my understanding with the insurance company, I talked to a couple of different insurance companies and they said you have to get a special addendum for stormwater which is an additional thing to your flood insurance and if you are a renter your renter insurance doesn't cover it. They cover fire, they cover water such as if a pipe breaks but they don't cover unfortunately stormwater. Then if it comes through the windows of the thing it actually goes through FEMA, so there is a couple of different things so when you go to your insurance company you got to ask a lot of questions before you do anything because it gets to be a lot of nonsense and then you get stuck and you got all this and nobody is paying for anything. Hopefully something does happen here but it may be a long, long time before we find everything out. Service Director Smith advised the city did at the time, there was a drainage ditch that runs in the woods on the Lincoln Blvd. and that drainage ditch has been clogged from time to time and used to run north to south. It dead-heads into one of their backyards on the north side in the back corner into a manhole just a little northeast of their property line. There is a series of manholes that run east behind, in the back of their backyards that are stormwater manholes that tie into the Irving Park sewer system. That said – that ditch was overrun with total amounts of water of 7 inches and rose up to the crest to the highest areas that they possibly can with the exception of the center section right in front of Madison which was dug out by a shovel. Somebody and these people saw and say that an individual actually dug an opening in there to relieve the water pressure and when that was done it drained literally half that ditch instead of going north to the manhole where it should have been and went into the area of Madison flooding from their front door through their heating vents almost directly across the street where Mr. Engle lives close to his front door. This couple here - house was at the lowest section which is the very northwest corner of Madison. The water on Madison was completely curb to curb at the second house off of Irving Park and the lawn service walk door step to door step by the end of the street – if that gives you a good idea. As soon as the Service Department got there and we cleaned out the catch basins and when we saw what

was going on, Frank went and blocked up the opening that was cut by a shovel according to the residents and then the water started to recede. That excessive amount of water running through the ditch; first of all, without getting into all the plays the amount of water running into the ditch where they are at and should be going into the catch basins and being drained. It also is close enough to the outfall at Shell Cove which is directly north about the 350 feet that I myself kind of think should be tied into there. But we are looking at that and then there are also drainage ditches that run east and west on the old railroad land that runs through there along Hawthorne and along Tennyson which are completely blocked. We had 1 business that we did a history on what was going on with the west side ditches, 1 business had done a project in their back and they filled the ditch in with their diggings from their pavement and their concrete – a major business in the city and it was left there. It was not reported until I found out about it just this week and it is on one of the ditches that we are going to have to go in and spend manpower to clean out and we have to reroute some water over in that end of the city. The majority of it is obstructions due to leaves, garbage and dumping's also by area people throughout the whole wooded area in that section. There is not just 1 issue, there is a whole series of issues and that is what I am trying to put together is a composite of all that. Then we can go from there. Mr. Engle advised of a large tree that has been probably growing there for 30 years right down that ditch. Mr. Engle stated so that ditch has been neglected, it has just been neglected back in there. The water has nowhere to go so once it has gotten all dumped down into this basin right at the end of Madison and it went over which it will again because it has nowhere to go north. Service Director Smith stated we are actually working on that. We have a main catch basin that was put in off of Treadway 6 years ago that is not channeling water, it is on the west side of Lafayette but it handles that Treadway water and part of that Treadway water through the Hawthorne and Tennyson ditches. Since they are blocked that water can't travel east and west on north section also. Law Director Graves stated I am glad the Service Director reiterated some of his comments, just for the folks on Madison – in the minutes from last night's Roads & Drains meeting, if you look on page 6 about a 1/3 of the way down is where the Madison situation is discussed.

**Devon Engle, 4880 Madison** stated I think one of the reasons why we are here tonight the ditch that was dug with the shovel, now all that is in there is a big glob of mud that Frank took and put in there when it flooded. Our concern is with all the rain we had this past weekend and now we are going to get more rain again, is there anyway we can get some more fill put into that ditch to sure it up until you can get the other ditch drained because we are worried about of course their property and they have 5 little kids and they are the ones that took the brunt of it and we don't want to see anybody on our street have to deal with that again. So that is our biggest concern is what we can do right now to stop it with that big ditch

dug with a big glob of soupy mud. I mean with all the rain that we have had over the last 2 weeks, that scoop was soaking wet when he put in there so is it going to hold through the rest of this. Is there any way that we can get some more fill put into that ditch temporarily, until you can figure out the rest of it. Service Director Smith advised without insult to what you are saying, there are other areas that didn't get a temporary fix that we are rushing to do right now. I will make a note of that and make sure that we are and one of the plans is to reroute that corner. That is just a couple of hours of work but right now I have them working on Walker Road because the poor people over there on Maple and Buckeye are inundated with a wall of water coming in from the woods on that Abbe section to Maple. So we have to take some drastic measures that are requiring some manpower. That is a temporary fix to lower the water table a foot and that is just a temporary fix – lowering the actual water table a foot. We had a gentleman whose house – imagine a house in the middle of your street under water and that is the corner house which floods a lot. So what we had to do was just alleviate a temporary situation over there and we have another one on Holl at the under bridges. I discussed that last night and those are areas which we are working on as quickly as we can but I will make it a point to get over there and try to get that reroute done before we get inundated with a massive rainfall. Mrs. Engle stated we are trying to be patient too. Service Director Smith advised it has been a couple of days and I have been on your street everyday with the exception of today checking on it.

**Elyssa Durell, 4840 Madison** stated in addition to talking about what you are doing at the corner alongside of our property which would also be Lincoln Blvd, where you stopped the water coming down – you have stopped it coming down on the street but did not stop it coming through our house because along the whole side of our property the water is running this way. Service Director Smith answered correct to the storm at the low end of your street – that is not the major issue of what had to do with the flooding. Are you talking in the ditch or are you talking outside the ditch? Mrs. Durell answered I am talking outside the ditch, through those woods – you stopped the water from running onto our street but in turn when you guys put that barricade up the water is now running. Service Director Smith stated it is running to the manhole. Mrs. Durell answered no it is draining right onto our property. Service Director Smith advised from what I saw it runs north to that manhole that is just north of Madison in the right of way where the chainsaws were at and then there are also some ditches that run east and west where the Hawthorne connection is. Those have to be cleaned out, those have to be done and that has to channel some of the water too in the northern section because those storm catch basins in everyone's backyards are not enough to handle ditch wash. What she is referring to is the amount of water traveling down that ditch overcomes it, it was a massive amount of water but it has to be rerouted. There is no way that those storm catch basins can handle it. Mr. Engle stated I think what

she is talking about Lenny is right next to their house too there is probably a small ditch, I think maybe the city might have dug in there. I don't know if they did, I don't know if the gentleman dug it but I think it needs cleaned out too. Service Director Smith advised I will come down there and you guys can show to me. Mr. Engle stated that should help alleviate the water on their property I think, it runs right in the woods. Mrs. Durell stated to add to that, the water was running straight – we had to open our back door and open the garage and let the water come straight through. Service Director Smith advised I didn't go back towards your backyard as I was worried about – you guys know I was right there. So I will come back and you can show it to me and we can go from there. Councilman Rosso asked Len how many guys do you have in the Road Department? Service Director Smith answered I have 3. Councilman Rosso advised so everything he talked about, all the places that need to be worked on there are 3 guys. So it is not like we have an army of guys that just aren't out doing things. Mr. Engle stated we didn't say they weren't when you see water going from door to door. Councilman Rosso stated I understand but a lot of times people don't realize we only have 3 guys. Service Director Smith advised if I may Madison is on the top of the list because it does affect so many home owners and that is how I am trying to prioritize it by how many actual houses are affected by a certain situation. I have to have some type of order to accomplish these tasks, otherwise we would be running over here and running over there and doing a partial job here and doing a partial job there. We had to stop the water first and get it out so it is going out and then we have to address the long term problem of removing the water by cleaning the ditches and opening up the catch basins and adding new pipe and new things. By all means, Madison is on the top of the list. It is up there with Kenilworth, it is up there with Holl (intersections), and it is up there with the bridges. There is a whole gamma of it but it is up there on the top of the list, as far as us zeroing in on and fixing it right now before the spring rains do come. Councilman Smith stated I think the other issue is like you said we got some big rains tomorrow, so there is not enough time and manpower to get to every area in the city. Service Director Smith stated it is averaging a day and a half between rainfalls. Councilman Smith stated over on Devonshire, that is a whole other side of the city. There is 6 feet of water in somebody's basement, there are issues all over the city but there is just not enough time in 2 days to address every one of them with a fix. Council President Podmanik stated we try to do what we can with what we have got, Mr. Smith is on top of it and I have got the utmost faith in Mr. Smith. Councilman Bring stated unfortunately when you get this much rain, everybody got hit and you feel terrible. I had 3 basements that got hit. Mrs. Durell stated I also feel that we called the Water Department numerous times, us residents on Madison and there were messages that should have been relayed to the Service Director and were not in regards to the sewage because when we went to him he was telling us that this is

the first that he is hearing of it. Councilman Bring advised I think with Mr. Smith doing the job now I think you will find that somebody is going to be on top of this from now on, he takes this very seriously and he has been working very hard to take care of this. Service Director Smith advised I think we discussed those issues and I believe that was with the previous Service Director or right around the time. Councilman Elliott advised in fact I think within the last year we have had 3 Service Directors, Lenny has been by far the best that we have had and I have talked to him and he has kept me posted and kept most of Council posted. I am in the same club you are, my basement flooded also. I live right next to the culvert right on Holl and it overflowed and it was in my yard. Something that I have talked to the city about numerous times. You mentioned sir that a tree was growing inside of a ditch, we have talked about cleaning out a lot of these ditches and the problem of erosion has been brought up. He said you know you cut those trees down and all of a sudden all you have there is dirt, not so much anything holding that dirt in place. So it is a double edge sword right now, we are just trying to figure out how to fix it and how to fix it in the correct way. Mrs. Engle stated we have lived there for 18 years and we didn't have any trouble until 3 years ago. Service Director Smith explained when the main ditch was made larger to handle more water and that is like I said one of the things that I am looking at because you can't do that without opening the end of it. Mr. Engle stated we don't want to block these residents off either over there on Treadway; you want the water running north just like he said.

Councilman Bring advised if any other residents have flooding make sure you come and notify him because we need to get that out there but a lot of people aren't saying anything. Service Director Smith advised I put all of their addresses down on the list because of the amount of water. Mrs. Durell stated we were the only ones on Madison that had the water in the house. Everybody that I have talked to on the street – we are the only ones that took the brunt, you know where we live and we are the only ones that had the water in and unfortunately yes we have 5 kids and yes we were put out of heat. In order for me to get my kids up the street to even get them out I had to walk them across everybody's property along the front. You know you have your insurance company telling you to leave but how can you get up the street when the water is over the fire hydrants. Service Director Smith advised I believe we have some pictures of Madison so that would really explain a lot. I think Frank or Shannon had taken some from the Water Department, the visual is self-explanatory. He advised any flooding victims call the Water Department and have their address put on the list 949-6259. Mr. Engle asked will that help in any way? Service Director Smith stated you might not have had water in the house but your sanitary were inundated with stormwater. So as far as that goes, that is important to know. I have sewage reports through the whole area mixed in with the stormwater. Mr. Engle asked that is what I mean does there



actually have to be damage to the homes to get this relief from the county? Service Director Smith answered no just if there is flood damage, if there is storm damages – it is the dollar value assessment of the damage done by the storm. The time that you spent cleaning the stuff off your front too, even right down to when we sent a water truck to jet your street off and I told you I was going to do that with mud. We have to add that time into it too because you got a quarter inch of mud down there in the road surface. We just need a break from the rain. Mr. Engle asked who is our Council person on Madison Avenue? Councilman Smith asked which side? Mr. Engle answered the south side. Councilman Smith answered the south side would be me and the north side would be Councilwoman Stark. Service Director Smith advised this gentleman here is referring to the ditch that I brought up last night on Holl that runs all the way down and the cleaning. I currently have actually pulled out the old plans from the last time it was done, I have them in my office right now and that is something that we will be addressing through Council this year. I mean through the Roads & Drains Committee on the amount of what we have to do over there. There is way too much water coming in, draining all of Sheffield - the amount of acreage south of the railroad tracks that we are taking water from is excessive – it is unbelievable. It snakes its way down Harris Road, down Shoemaker Ditch, crosses the railroad tracks, under the railroad tracks, works its way from Harris Road westerly through Lake Breeze and down on both sides and literally swamps up and takes in all that water from the south side and then it heads to the ditch where the 4 bridges are; Belle, Brockley, Knickerbocker and Holl. The catch basins are falling out like I reported last night on the bottom of the bridges, the brick catch basins/the tie-ins for the storms have to be readjusted so those are all things that we are going to have to work out as a team to address and get fixed so that that ditch can handle more water. It can at the mouth and it can down by the lake and it can underneath Lake Road/box culvert was put in several years ago down by the covered bridge and it was more than adequate in handling that amount of water that came through. The problem is upstream we have trees, we have branches and growths and we did a walk through from Ferndale all the way down through Holl to the bridges and then went underneath the bridges also so we have an accurate representation of where there is problems in there and also reported that last night to Council. So we are definitely aware of it and we are going to be working on trying to get that done. Councilman Elliott stated more than just getting it done, it is getting it fixed because like I said it is more than just cleaning that ditch out. You take all that vegetation out of there and you are going to have bigger erosion problems than we have now. Law Director Graves advised what has to be pointed out in terms of that ditch there, there are 2 problems – 1 is addressing the flow of water and any impediments in that ditch/2 is that ditch is eroding and getting very close to a lot of the neighboring property. In fact there is some property along there where their fence is actually kind of sinking in and what Mr.

Elliott is absolutely correct, a lot of it is trees and roots that are growing along the sides are actually preventing the erosion and actually protecting those property owners. So you start removing that to open up the flow of water than you start opening up an erosion problem where people might start losing their property into the ditch. So it has to be looked at very carefully and balance both of those concerns. Councilman Elliott stated it is something that we have talked about for years; since I have been on Council I know that for sure. A couple of years ago we actually went in through and found out who owns that property and it is the State, several private property owners – so we have got a lot of hurdles to cross before we fix it but the wheels have been in motion for a long time. Like I said you just don't want to clean the ditch out because you are going to have bigger problems. Service Director Smith advised if I may add one thing; we might be going in there and just removing debris from the actual water course itself where there is blockage and stuff but there is also going to be aeration riff-raff that has got to be placement in there to slow down the flow of water so it doesn't erode so quickly the sides or areas where the waters going. That is going to have to be engineered, make no thing about it. That is going to have to be looked at with a fine tooth comb and be engineered to actually curtail the erosion but the immediate thing is there are several blockages in there caused from trees and branches intertwined/forming into a giant nit-nat which we have to go in there and we have to cut it out with chainsaws and get it out. It is just floating debris that has lodged itself on corners and areas like that. That will help in the immediate or very near future because I don't think we are going to get 7 inches of rain again in 6 hours. That is a 50-year rain so I think we have a little bit of time to at least try to get the flow restrictions out of there. **UNFINISHED BUSINESS: None.** **NEW BUSINESS:** \*Motion by Huska/Second by Bring to amend the agenda to include Council#012, #013 and #014 to tonight's agenda. **ROLL CALL TO AMEND TONIGHTS AGENDA:** Yeas All – Smith, Huska, Rosso, Bring, Elliott, Kovach, Stark.
