*******ADMINISTRATIVE REPORTS*******

MAYORS REPORT: Mayor Piskura advised you all should have been copied on the letter from the EPA, they came in and did an assessment on our sewer system and I wanted to give some at-a-boys to the Service Department and the Service

Director. I think he will go over it a little more in his report but very good findings. I wanted to give an at-a-boy everybody that responded to the outfall for an investigation of a fuel spill – they did a wonderful job. Shoreway Shopping Center as you are all aware and we have talked, the prospect that we had for a major tenant has elected not to move forward – no secret. Prior to them making that decision we had been doing basically the bare minimum at the shopping center, only what we had to keep it functional. Now that it looks like we are not going to be able to get a major retail development in there all in one shot and certainly not by the end of this year. I would like to do some improvements to the center itself to continue cleaning it up a little bit and maybe rehab some of the units and make them suitable to be occupied. Actually I have asked the Service Director to start to put together a work plan for items that need to be done up there and I would like to refer that subject for discussion to the Buildings & Lands Committee of Council to get it on your agenda of what exactly needs to be done. Lastly we advertised for dispatchers last November and got a bunch of applications/sorted through them from basically after Christmas to about February we were taken them. We probably got at least maybe 125, before the summer time rolls around I would like to hire 4 part-time dispatchers and while we were doing interviews we came upon 1 exceptional candidate that applied to be a dispatcher but he was so well qualified and willing to work as a part-time patrolman that I would like to hire a part-time patrolman as well. These are part-time employees, all they are doing is filling in for the hours that are necessary/they are budgeted for, we are just trying to improve our depth of resources. So with that I am hiring and I would submit it to you for confirmation; dispatchers are – Jan Fish, Laura Bretti, Laura Espitia and Krysten Thomascik. The part-time Police Officer is David Pace. *Motion by Huska/Second by Bring to accept the report. Yeas All./

FINANCE DIRECTOR REPORT: Finance Director Smith advised I just have one small item and this really goes hand-in-hand with the Walker Road Phase III Don Mould ordinance. This is the balance that we owe, the money is there but I would like to appropriate it for payment in conjunction with the passing that other legislation for Don Mould. So I put that before you and then of course I need what we brought over from Finance & Claims for the solar project ordinance is also in your packet. *Motion by Huska/Second by Bring to accept the report. Yeas All.

TREASURER REPORT: None./SAFETY DIRECTOR: None./SERVICE DIRECTOR: Service Director Smith reported I am just going to touch on a few things but there are many things that the Service Department/Water Department/Building Department are dealing with and I would ask that you refer to a lot of the minutes of the committee meetings where I am trying to report on the different things – more detail in each of the different committees such as Buildings & Lands or Park Board, etc. There are a lot of things going on at the same time. Tonight I will give you a brief synopsis of some of the most important that

happened to be going on currently. Number 1; as many of you know Shoreway's Rite Aid has had some major water leaks on the roof. This was due to issues that are dating past our purchase of the shopping center/ownership. We will be correcting them and keeping them in kind of different state. Right now all the leaks have been repaired – that is number one, the second will be going in there and fixing the issue which will be the installation of some drains to remove the water. The previous construction that was done as a facelift on the shopping center omitted the drains in sections of the roof causing this issue because of the fact at that time the roof was redone. The whole drainage system was changed from what it originally was and that is being taken care of as of right now/we are about 95% complete with that except for the back area. Rite Aid seems to be happy, I have kept in total contact with them but I know there have been a lot of customers who have complained and inquired and they just didn't understand that you can't fix a roof when it is raining or when there is 5 inches of water on it. It takes a certain amount of time to pump the water off and as you know we have had rain storms, ice storms, snow storms on a regular basis that every day that we get a dry day to break we have a day and a half before it seems like it is raining again. Yesterday we had an issue at the Cove Beach outfall, we were notified of a diesel smell near the mouth along the lakeshore of the Cove Beach outfall and the Fire Department responded with the Service Department. The Fire Department called in the appropriate authorities along with the response team which was the US Coast Guard; Special Team and the Ohio EPA and that course of the investigation is being run by the Coast Guard. The follow through is not complete, it turned out to be a residential source of a small quantity. More information will be forth coming from the Coast Guard as time goes on but at this point and time there is not much more information except that it was boomed/cleaned up and I believe Chemtron was cleaning it up today - all day, along with yesterday and last night to the satisfaction of the Coast Guard. It turned out to be like the Mayor said a very good response to a situation that could have been worse but it was of a small quantity and the investigation is still on-going with them. We will get reports in the future. The third thing is I have prepared a storm damage assessment I guess you could say. After we turned in from the February 28th storm, if you remember, I requested that we had anybody call in and we turned those numbers over or we collected those numbers in case we got money coming in from the EMA and federal sources – that did not happen. We still had to file a public dollar loss with EMA. What I did was I wanted Council and everyone to be aware of what that storm actually costs the city. So in the process of doing that I collected data along with insurance information from residents of how much their claims were, how much their original claim was, how much the insurance company paid. I have talked to a lot, a lot of residents. We compared the water/rain water infiltration into the sanitary system and it was metered on the next day after the 28th, so we know how much

entered into the system from that storm and I would like to at least read this to you guys – “storm damage from the storm on February 28, 2011 was 5 inches of rain plus 2 inch rain equivalent of snow melt and that occurred in 6.6 hours according to the reports on that day by EMA. I have requested resident information on flood damage and compiled a flood damage assessment as follows; documented 89 homes with basement flood damage at estimated costs of damage per home at \$4000.00. This is a best guess average based on insurance reports of claim damage that I could come up with because of course a lot of people claimed a lot more money; there were \$10,000.00 to \$12,000.00 claims that were \$2000.00. But if I may add 1 furnace is less than \$4000.00. The best guess average on the insurance reports of claim damage that I could come up with I believe to be fairly good and this amount totals \$356,000.00. You add the public estimate of the public storm damage which is the amount submitted to EMA of \$31,528.00 and it gives you a conservative estimate on the low side of \$387,528.00. Therefore if one estimates only half of the homes actually called the city and reported these numbers they would increase by the following; 178 homes with the same multiplier of \$4000.00 comes out to \$712,000.00 of public damage estimate and you add \$31,528.00 to the submitted storm damage to the government side and you come up with \$743,528.00. So the range runs – the best guess estimate of what the damage we had on that night and I think I have covered it fairly good is a range running from \$387,528.00 to \$743,528.00. It is just a best guess estimate and there was also commercial damage of approximately \$3000.00 that you can add to that but that number is kind of small.” So I wanted you guys to be aware that 1 night’s rainfall – that is my best guess estimate of what it costs residents of the city. We are continuing with cold patch throughout the city, currently we are working on Shoreway and we are working on the entrances; the Sheffield entrance and tomorrow we will be out in the parking areas working on that. Lastly we received yesterday a copy of the environmental protection agency; sanitary requirements, he read the following under requirements “The July 24, 2008, sanitary survey letter discussed a number of regulatory and non-regulatory issues relative to the operation of a public water system. Based upon this writer’s recent sanitary survey, it appears all items requiring attention at that time have been adequately addressed. In addition, there were no items discussed during this survey that would be considered “Required” action items. The City of Sheffield Lake is to be commended for making significant progress with regards to compliance activities since the past survey. We do recognize that the Administrative Orders issued by U.S. EPA for Stage 2 Disinfectants/Disinfection Byproducts Rule violations have been rectified and all administrative actions have been cleared.” He continued I believe everybody has a copy of that and it goes into much detail, specifics on the following pages and I would like to commend Tom Erwin for his responsible application of his duties as operator and responsible charge since the appointment

of Tom in that capacity because he has taken it very serious and this is a great reflection of it. Councilman Bring advised I would like to thank everybody that came over to the outfall for that spill, very professional response. Tom Erwin was a part of that and I think everybody conducted themselves very well and they were very calm about it and a special thanks to Chemtron because they acted and then stayed afterwards and also there all day today cleaning it up. I would report that it is cleaned up and looks very nice and I was very happy to everyone take care of that. I also want to thank Len as I called him and he responded very quickly to the scene. *Motion by Huska/Second by Bring to accept the report. Yeas All./**LAW DIRECTORS REPORT:** Law Director Graves reported I do anticipate bringing a settlement proposal to Council in the near future for the Bowling Alley litigation that we have talked about. We have a tentative agreement and that will be forthcoming for your review and consideration. We are going to be a proposed legislation to the Safety Committee to revise the pay ordinances for the part-time dispatchers. I anticipate having that ready for the Safety Committee for the first meeting in April for their review and consideration. We are going to be bringing a couple of pieces of legislation before Council in the near future to tie up some loose ends with our tax ordinance – RITA has notified us that there is some housekeeping that needs to be done. So we have drafts of those and will probably be getting those out/emailed out tomorrow which will give you plenty of time to look at them prior to the first Council meeting in April. He continued the Service Director and I are continuing to work on the required updates to the stormwater ordinances; the pre-imposed construction, storm runoff and the site runoff and also the infiltration ordinances that are required to be updated. Those should be forthcoming very soon. One piece of information, as you know we have a 3-member Civil Service Commission and 1 member did pass away. Another member is going through some personal health issues and will probably be unavailable for an extended period of time, leaving only 1 member of the Civil Service so they will not be able to meet probably for quite some time unless there is someone else that is appointed to that Commission. So just that everybody understands if there is a gap in their meetings. He reviewed tonight's legislation and advised for addition if Council so chooses to add to the agenda – Council#018 which is the appropriation ordinance and then we have the 2 ordinances that we talked about at Worksession and I have reviewed those and discussed with the Finance Director at some length and this legislation is going to be necessary. The change orders were unanticipated and were necessary for the general safety. Those ordinances are going to be necessary so that we can close that up. I think that when we do have the vote of Council to add to the agenda on the confirmation of the part-time dispatchers I think that certain members of Council may wish to raise conflicts and abstain from the vote so I would just ask that those be voted on independently

rather than in a block. *Motion by Huska/Second by Bring to accept the report.

CITIZENS COMMENTARY:

Ann Marie Woltman, 649 Sheffield stated I missed the last Council meeting so I wasn't aware until I read the minutes about all the concerns about the flooding. There was a problem on our street also; I have a sump pump so fortunately for me I only had a little bit of water. But the lady on the corner of Lake Road and Sheffield, she had 6 inches and it took out her furnace motor. My question is was this published in the paper or any other way, did it ever get into the newspapers at all? Service Director Smith answered yes, it was an option – the County EMA required at first information on the public sector and if they in turn received federal funding than of course we would need all of that information. So we tried to ask for it in advance as soon as we could. John Edwards put it into the paper, so yes it was there. As a matter of fact I had to straighten out a lot of calls that I had gotten, there were people with ranches that didn't have basements that had actual water damage. But yes it did get out and that is why there is a range in that figure on the ones that actually did report and the ones that didn't. Ms. Woltman stated I haven't talked to her because I was out of town and I will have to call and see if she reported it. Are you still collecting that? Service Director Smith answered no I am not, those numbers were turned into Emergency Management. Well those numbers weren't, the public numbers were but I will take her address and add it to the list for our documentation. I will be glad to but there is nothing that I can do because we didn't get any assistance. Ms. Woltman stated the only other question that I had is do they routinely clean the pipes? Service Director Smith answered absolutely; the reason for the flooding in a lot of the homes in the basements was due to the fact that there was 7 plus inches. Like I said 7 plus inches of rain in a period of 6.6 hours with a lot of the storm drains covered with snow and ice, so if you can put yourself back to when that was. When that rain came, it just raised and stayed up on the surface and then went into the footer drains. There are actually drains underneath slabs by your house; gutters and depending on where you live in the city determines how many of them are – infiltrated the sanitary sewers. Our pump stations could not keep up and neither could any of the other adjoining cities. I believe almost every city in the County had the same issue. Ridgeville was hit really, really bad. They had people who actually lost houses. So once that system gets 100% full then what happens is it starts discharging and alarms go off when we discharge into the lake because it can't handle the overflow and Lorain can only take so much. Then what happens if it keeps raining is the system starts to back up and that raises the level. We had to our best guess estimate and I figured in our calculations approximately between 18 and 20 million gallons of extra water that went to the City of Lorain that we have to pay sewage on because of that.

Bob Ebenschweller, 362 Cove Beach stated with regard to the mini disaster that we had yesterday. I had talked to one of the Coast Guard guys up there yesterday and at the time he told me that they pin-pointed the source they thought. The morning paper in the Journal that it was a local excavating/landscaping outfit or whatever and that they accepted complete responsibility for it. I guess the question at what level are citations in cases like this issues, are they at the local level, EPA or are there any citations going to be issues at all? Service Director Smith answered the investigation is not over with Bob and that will be determined at the end of the investigation. The Coast Guard said last night even though they are not the paper – they are the ones doing the investigation, they said that when the report is done they will submit a report and that will contain the information if that is what you are looking for. They also stated it was a very small amount and they did not expect the issue to create a big issue because of the simple fact the resident involved was paying for the clean-up by a licensed company that does that. But we were also advised that it is not complete and when it is complete we will get a report. Mr. Ebenschweller stated I remember some guy over at the Knickerbocker changed his oil one time and dumped it right down the sewer and they hammered him pretty heavy in local court here. I think it is pretty substantial if it were done purposely and I thought about it of what could happened if it could have been ignited somehow and blown the manholes off all the way up the street or something like that. But evidently it appears it is not that bad but still I wonder if there will be any consequences to the person for this in a legal sense. Service Director Smith answered we will follow the investigative authority and how they pursue at the end of their investigation, so it is immaterial at this point and time to even elaborate or guesstimate – there is no reason to. Mr. Ebenschweller stated the other issue I see you got on here is the overages on Walker Road and at what level do they authorize these changes. I mean does it ever come before Council or is it done at an administrative level somehow and at what level and who authorized these changes. There is no name that I can see on there on the part of the city, it is as if the contractor himself just said well I paid more to do this. Law Director Graves advised the change orders are all initialed by the Project Coordinator at the discussion of the Service Director and the Mayor and the Engineer. Mr. Ebenschweller asked who was the project coordinator? Law Director Graves answered William Gardner. Mr. Ebenschweller stated okay.

Mark J Erdei, 4015 Tennyson stated I am glad you brought that up Bob because I was wondering how the city handled the costs over-runs, what Don Mould said we got all this extra stuff and how did that work out? Law Director Graves answered this was discussed at some length at the Worksession last week and the over-runs were not something that Don Mould just came back and said we need more money. These were specific items that were discussed with the city in response to safety concerns regarding the placement of the sidewalk and its proximity to the bike trail

and when that had to be shifted for safety concerns it necessitated additional work because of the difference in elevation between the sidewalks and the aprons and the driveways. So it was really a request from the city to make the project safer. Mr. Erdei asked with the State of Ohio going to eventually get their claws in regulating internet cafes, will that effect our ordinance that is in place right now or is everything going to stay the same. I mean it is kind of an up-in-the-air question but I mean the State of Ohio comes back with these regulations will that affect our fees? Law Director Graves advised it could. Mr. Erdei asked so you would have to draw up an ordinance possibly? Law Director Graves answered at this point no one is really sure what direction the State is going to go, the new Attorney General is just discussing it and he has got a task force and everybody is trying to decide what direction to go with this. It could have impacts but at this point it is too early. Mayor Piskura stated just to get it on the record one more time, when this issue first came to us locally we begged the State for direction and they didn't want to touch it. The Attorney General's office, the Governor's office – so we acted on the best persuasive authority that we had or I should say Council acted with the best persuasive authority they had in front of them. I personally and I know David personally hounded the State for some direction and they refused to get involved. I just wanted that on the record again. Mr. Erdei stated on a lot of these cities working on getting the law passed for texting while driving, has our city ever looked into that? Councilman Bring quipped the first 3 letters they would be through the city. If I were texting I would get through the 1st one. The Safety Committee has not addressed that and I don't think there are any plans on addressing it, nothing has come from the Police Chief or anything like that. Our city is only 3 miles long and 1 mile wide at the very widest. It would be very hard for them to prove if they were texting going through the city, I mean it is possible. Some of the cities have adopted that but like I said it would have to come from the Police Chief.

Rosa Gee, 588 Kenilworth stated first question I have is more of a statement; May 2004 the Stormwater removed 2 sections of my sidewalk. Periodically each administration I bring up the fact that it has never been replaced and we want it replaced. It is that time where administration is going to change again so once again I would like to bring up the issue. I really do need this replaced and we really have been patient enough considering May 2004 and this is already 2011. So I am really hoping this year both sections are replaced. The first Service Director during that time period Mr. Gardner saw what parts of the sidewalk were removed, we also have pictures, and we have also turned in pictures. I understand the road has changed, I also understand that the ditch has been filled in with piping but either way we do want both pieces back. Second question I have is for our Service Director, Lenny you mentioned earlier about the infiltration from stormwater. What are the Service Departments plans on looking more into correcting the

problem of the infiltration? Service Director Smith answered we have already started them we are doing manhole inspections during the course of a rain event; we are doing it in zones and as those zones to each pump station. Mrs. Gee asked have you determined which zone yet is the worst infiltration? Service Director Smith answered actually no I haven't but I am working on each pump station in each zone independently. It is not a good thing that as you know that infiltration occurs but when it does it leaves a signature and that signature is what we are in the process of documenting. I have old maps of almost all the different storm sewers and the changes to the original storm sewers within the city out currently and as I just discussed with Mr. Skellenger the different manhole maps and we have expanded the program that we have started and have started documenting. Currently I can tell that we have 2 bad manholes on Kenilworth with the south end and that is verified during the rain event and that is in the process of being corrected. We have had 4 or 5 manhole cover lids that were sanitary that slid off their base or moved off their base by whatever reason allowing infiltration when the ditch was filled with water. They were of course sanitary sewer manholes that were right next to ditches and they allowed water infiltration to come up underneath the lid base and down in there and we have corrected those. When you see a ditch going around a manhole cover from this day forward, that is because that manhole was compromised and it has been repaired. So there is a program going on. We had an infiltration analysis done in 1974; we had infiltration analysis throughout the years by different Councils and different Administrations. That too is all being looked at and being examined at the rate, quantities and as you knows the sewage is metered leaving the City of Sheffield Lake into Lorain. So if we take the yearly totals of exactly how much occurs and apply an overlay of a rain event, we can get a great idea to how much infiltration we will have per half inch of rainfall/for 1 inch of rainfall/for 2 inches of rainfall and all that stuff is being analyzed and is being compiled at the same time. All I can tell you is that I am in the process of doing it. Mrs. Gee asked are you still keeping up on the best management practices over at Pleasantview, I see it not getting any better over there and the tire pile came back by the way? Service Director Smith answered we have several issues over there at Pleasantview and those are being addressed. I can tell you we are even reviewing the changes that were made to the surface drainage over there after the development was put in. There is a lot of history that I have to review to see why things happened or occurred, especially in the north end where that outfall is. Mrs. Gee stated a few of the piles have grown, they went down half way and now they are bigger than the original piles were.

Bob Ebenschweller, 362 Cove Beach stated I have an addition, in regards to these change orders. There is one on here for a yard drain on Lakeview Avenue and I wondered that went well beyond the scope of what the original ordinance called for and all these change orders don't have a date of acceptance or a signature by

somebody on behalf of the city. Council Pro Tem Rosso showed where the change order was initialed for approval. Mr. Ebenschweller stated what about the date? Council Pro Tem Rosso answered I don't know about the date on it but I just know that is Bill's signature. Mr. Ebenschweller stated within the last year, 6 months or 3 weeks? Council Pro Tem Rosso answered no that was back whenever the project was going.

Debbie Belaska, 4014 E Lake stated I am hearing rumors that Lakeside Eats-n-Sweets is going to go up for sale, has anybody heard anything? No one on Council had heard anything.
