RESOLUTION NO. **4-18**

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING BETWEEN THE LORAIN COUNTY COMMISSIONERS AND THE CITY OF SHEFFIELD LAKE TO PARTICIPATE IN AN EMERGENCY NOTIFICATION SYSTEM AND THE DECLARING OF AN EMERGENCY.

**WHEREAS**, the Lorain County Commissioners desire to enter into a contract with Inspiron Logistics to implement a countywide Emergency Notification System; and,

**WHEREAS**, the cost to the City of Sheffield Lake to participate in said program is Thirteen Hundred Seventy-One Dollars (\$1,371) for three years (\$457/year); and,

**WHEREAS**, the system will provide voice, text, email, pager and social media notifications of such information as weather alerts, evacuation warnings and missing child/adult/ Amber alerts; and,

**WHEREAS**, it is in the best interest of the City of Sheffield Lake to participate in such a program.

**NOW, THEREFORE**, be it resolved by the Council of the City of Sheffield Lake, Lorain County, State of Ohio, that:

- Section 1. The Mayor is hereby authorized to enter into a Memorandum of Understanding with the Lorain County Commissioners for the implementation of a countywide Emergency Notification System.
- Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
- Section 3. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property,

health, safety and welfare in the City the emergency being the immediate necessity of entering into a Memorandum of Understanding with the Lorain County Commissioners for the implementation of a countywide Emergency Notification System.
