ORDINANCE NO. 9-18

AN ORDINANCE AMENDING SECTION 139.02 OF THE CODIFIED ORDINANCES OF SHEFFIELD LAKE REGARDING THE DIRECTOR OF PUBLIC SERVICE

**WHEREAS**, Article V, Section 5 of the Charter of the City of Sheffield Lake provides that the Director of Public Service shall be the head of the Department of Public Service; and,

**WHEREAS**, section 139.02 of the Codified Ordinances of the City of Sheffield Lake states that the Director of Public Service shall be a full-time employee of the City; and,

**WHEREAS**, it is in the best interest of the City of Sheffield Lake to amend section 139.02 to allow for the appointment of a part-time Director of Public Service.

**NOW THEREFORE**, be it ordained by the Council of the City of Sheffield Lake, State of Ohio:

Section 1. Codified Ordinance Section 139.02 is hereby amended as follows:

**139.02 DIRECTOR OF PUBLIC SERVICE.**

- (a) The position of Director of Public Service ~~shall~~ *may be either a full-time or part-time position within the City at the discretion of the Mayor.*
- (b) The Director *of Public Service* shall have all of the responsibility and duties provided in Article V, Section 5 of the Charter and shall, in addition thereto, have all such duties and responsibilities as may be delegated to him by the Mayor, or by ~~ordinance~~ *Ordinance* of Council, provided such duties are consistent with the Charter.
- (c) The salary of the Director shall be payable on a bi-weekly basis and shall be allocated to the following funds as set forth:
  - Forty percent (40%) to the Water Fund;
  - Forty percent (40%) to the Sewer Fund;
  - Twenty percent (20%) to the Street Maintenance and Repair Fund.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
