

AN ORDINANCE AUTHORIZING THE MAYOR TO ADVERTISE FOR BIDS FOR AND TO ENTER INTO A CONTRACT WITH THE LOWEST AND BEST BIDDER FOR THE PURCHASE OF PREMIUM NO LEAD GASOLINE, REGULAR NO LEAD GASOLINE, PREMIUM LOW SULFUR DIESEL FUEL, #304 LIMESTONE, #57 LIMESTONE, #8D LIMESTONE, #8W LIMESTONE, #1 LIMESTONE, AND ASPHALT PLACEMENT FOR ALL OR PART OF THE 2018 ROAD SECTIONS TARGET LIST, AND THE DECLARING OF AN EMERGENCY.

WHEREAS, it is in the best interest of the City of Sheffield Lake, Ohio to advertise for bids for and to enter into a contract with the lowest and best bidder for the purchase of premium no lead gasoline, regular no lead gasoline, premium low sulfur diesel fuel, #304 limestone, #57 limestone, #8d limestone, #8w limestone, #1 limestone, and asphalt placement for all or part of the 2018 road sections target list.

NOW THEREFORE, be it ordained by the Council of the City of Sheffield Lake, County of Lorain, State of Ohio:

- Section 1. The Mayor is hereby authorized to advertise for and to enter into a contract with the lowest and best bidder for the purchase of premium no lead gasoline, regular no lead gasoline, premium low sulfur diesel fuel, #304 limestone, #57 limestone, #8D limestone, #8W limestone, #1 limestone, and asphalt placement for all or part of the 2018 road sections target list as hereinafter described.
- Section 2. All aggregate bid prices shall include the cost of delivery per ton.
- Section 3. The asphalt placement road section target list shall consist of one or more of the street projects as set forth in the 2018 Asphalt Placement Target List which is attached hereto and incorporated herein by reference.
- Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 5. This ordinance is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of advertising for bids for and entering into a contract with the lowest and best bidder for the purchase of premium no lead gasoline, regular no lead gasoline, premium low sulfur diesel fuel, #304 limestone, #57 limestone, #8D limestone, #8W limestone, #1 limestone, and asphalt placement for all or part of the 2018 road sections target list as herein described.
