ORDINANCE NO. 19-18

A RESOLUTION AUTHORIZING THE MAYOR, OR HIS DESIGNEE TO ADVERTISE FOR BIDS AND TO ENTER INTO A CONTRACT WITH THE LOWEST AND BEST BIDDER FOR THE CONSTRUCTION OF PUBLIC RESTROOM FACILITIES AT THE COMMUNITY PARK BOAT LAUNCH, AND THE DECLARING OF AN EMERGENCY.

**WHEREAS**, Resolution No. 22-17 passed April 25, 2017 authorized the Mayor to apply for Ohio Department of Natural Resources Ohio Nature Works Grant funds to be used for public restroom facilities at the Community Park Boat Launch; and,

**WHEREAS**, the City of Sheffield Lake has been awarded an Ohio Nature Works reimbursement grant in the amount of Fifty-Two Thousand Two Hundred Forty-Four Dollars (\$52,244) for the construction of public restroom facilities at the Community Park Boat Launch; and,

**WHEREAS**, the engineer's estimated total cost of the project is One Hundred Thirty Thousand Dollars (\$130,000); and,

**WHEREAS**, it is in the best interest of the City of Sheffield Lake, Ohio to advertise for bids for and to enter into a contract with the lowest and best bidder for the construction of public restroom facilities at the Community Park Boat Launch.

**NOW, THEREFORE**, be it resolved by the Council of the City of Sheffield Lake, County of Lorain, State of Ohio:

Section 1. The Mayor or his designee is hereby authorized to advertise for bids and to enter into a contract for the construction of public restroom facilities at the Community Park Boat Launch with the lowest and best bidder after advertisement in a newspaper of general circulation within the municipality for a period of not less than two, nor more than four consecutive weeks.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of authorizing the Mayor or his designee to advertise for bids and to enter into a contract with the lowest and best bidder for the construction of public restroom facilities at the Community Park Boat Launch.
