## COUNCIL NO. 020 SPONSOR: Mayor Bring RESOLUTION NO. **20-18**

A RESOLUTION AUTHORIZING THE CITY OF SHEFFIELD LAKE, OHIO TO PARTICIPATE WITH THE OHIO DEPARTMENT OF TRANSPORTATION FOR THE PURCHASE OF SODIUM CHLORIDE FOR THE 2018-2019 WINTER SEASON, AND THE DECLARING OF AN EMERGENCY

*WHEREAS*, Section 5513.01 (B) of the Ohio Revised Code provides the opportunity for Counties, Townships, Municipal Corporations, Port Authorities, Regional Transit Authorities, State Colleges/Universities and County Transit Boards to participate in contracts of the Ohio Department of Transportation for the purchase of machinery, material, supplies, or other articles; and,

**WHEREAS**, to participate in the Ohio Department of Transportation's Contract for sodium chloride the City hereby agrees to purchase a minimum of 90 percent up to 110 percent of the estimated 750 tons of sodium chloride (rock salt) exclusively from the vendor awarded the sodium chloride contract for the county in which said political subdivision is located after the competitive bidding process is complete.

*NOW, THEREFORE*, be it resolved by the Council of the City of Sheffield Lake, Lorain County, State of Ohio, that:

- Section 1. This Council authorizes the Mayor to enter into an agreement to participate with the Ohio Department of Transportation Program for the purchase of sodium chloride (rock salt) for the winter of 2018-2019.
- Section 2. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, property, health, safety and welfare in the City the emergency being the immediate necessity to authorize participation in Ohio Department of Transportation Rock Salt Program.
