RESOLUTION NO. **38-18**

A RESOLUTION AUTHORIZING THE CITY OF SHEFFIELD LAKE TO ACCEPT AND APPROVE THE DONATION OF SIX THOUSAND ONE HUNDRED TWENTY DOLLARS FROM VANGUARD CHARITABLE THROUGH A GRANT FROM THE BRIAN A. BASS MEMORIAL FUND FOR THE PURCHASE OF FIFTEEN BALLISTIC VESTS FOR THE POLICE DEPARTMENT AND THE DECLARING OF AN EMERGENCY.

WHEREAS, the City of Sheffield Lake is in need of fifteen new ballistic vests for the police department; and,

WHEREAS, the City of Sheffield Lake has secured a grant through the Department of Justice to cover 50% (\$6,120.00) of the cost of the ballistic vests; and,

WHEREAS, Vanguard Charitable has offered to donate the remaining 50% (\$6,120.00) of the cost of the ballistic vests through a grant from the Brian A. Bass Memorial Fund; and,

WHEREAS, it is in the best interest of the City of Sheffield Lake to accept this donation for its stated purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SHEFFIELD LAKE, STATE OF OHIO:

- Section 1. That the City of Sheffield Lake hereby accepts and approves the donation of Six Thousand One Hundred Twenty Dollars (\$6,120.00) from Vanguard Charitable through a grant from the Brian A. Bass Memorial Fund for the purchase of fifteen new ballistic vests for the police department.
- Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees which results in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 on the Ohio Revised Code.
- Section 3. This Resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate

necessity of approving the donation of six thousand one hundred twenty dollars (\$6,120.00) for the purchase of fifteen new ballistic vests for the police department.
