A RESOLUTION AUTHORIZING THE CITY OF SHEFFIELD LAKE TO ACCEPT AND APPROVE THE DONATION OF FIVE HUNDRED DOLLARS FROM AL G. KELLY MILLER BROS. CIRCUS DBA KELLY MILLER CIRCUS FOR THE USE OF CITY SERVICES AND THE DECLARING OF AN EMERGENCY.

**WHEREAS**, Al G. Kelly Miller Bros. Circus dba Kelly Miller Circus (Circus) was granted a special event permit to operate a circus at the Shoreway Shopping Center from August 3, 2018 through August 5, 2018; and,

**WHEREAS**, while utilizing the Shoreway Shopping Center area, the Circus utilized various City services including water, electricity and trash collection; and,

**WHEREAS**, the Circus has donated Five Hundred Dollars (\$500.00) to the City of Sheffield Lake to compensate the City for the use of these services; and,

**WHEREAS**, it is in the best interest of the City of Sheffield Lake to accept this donation for its stated purpose.

**NOW, THEREFORE**, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SHEFFIELD LAKE, STATE OF OHIO:

- Section 1. That the City of Sheffield Lake hereby accepts and approves the donation of Five Hundred Dollars (\$500.00) from Al G. Kelly Miller Bros. Circus dba Kelly Miller Circus to compensate the City for the use of City services including water, electricity and trash collection.
- Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees which results in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 on the Ohio Revised Code.
- Section 3. This Resolution is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of approving the donation of five hundred dollars (\$500.00) to compensate the City for the use of City services during the Circus
