ORDINANCE NO. 58-18

AN ORDINANCE INCREASING THE RATE OF PAY FOR THE POSITION OF MAYOR OF THE CITY OF SHEFFIELD LAKE AND THE DECLARING OF AN EMERGENCY.

WHEREAS, Article IV, Section 7 of the Charter of the City of Sheffield Lake provides that the Compensation for all elected officials shall be fixed at least forty-five (45) days prior to the last date for the filing of nominating petitions for the next terms beginning on the first day following certification of their election; and,

WHEREAS, the rate of pay for the Mayor of the City of Sheffield Lake is currently Eight Thousand Eight Hundred Dollars (\$8,800.00) per year; and,

WHEREAS, the Council of the City of Sheffield Lake deems it to be in the best interest of the City to increase the rate of pay for the position of Mayor.

NOW, THEREFORE, be it ordained by the Council of the City of Sheffield Lake, State of Ohio:

Section 1. The rate of pay for the part-time position of Mayor, the present rate being Eight Thousand Eight Hundred Dollars (\$8,800.00) per year as established by Ordinance No. 100-96 is hereby increased to Thirty-Two Thousand Dollars (\$32,000) per year, payable biweekly, effective the first pay period of 2020.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees which resulted in such formal actions, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This ordinance is hereby declared to be an emergency measure made necessary for the preservation of the public peace, health, safety and welfare of the City of Sheffield Lake, Ohio, the emergency being the immediate necessity of adopting a pay increase for the Mayor of the City of Sheffield Lake, effective the first pay period of 2020.
