We are doing it like we always do. We will plow main streets then secondary streets and side streets are last. With the wind blowing like it is, it didn't do much. They were out since 2:45am today. Republic called and said they are not picking up garbage today. We still have people going into unlocked cars, so lock your doors. It is happening in early morning hours like 2am. If anyone sees anyone out after curfew, call the police and let them talk to them. We need to know when you see them. We had 40 cases of COVID last week. That is by far the most.

**/SUPERINTENDENTS REPORT:** Superintendent Hastings reports with the snow, after being at this for three decades, I can tell you the city is better positioned now with 7 plows then in my whole career. It snowed for 14 hours straight. I take the complaints to heart, but we are working hard out there. I had two new projects scheduled to start this week and I did meet at both on Monday. The first is the overflow emergency pipe at pump station 2. They mobilized their equipment but pushed it back a week due to the

weather. We also had a brand-new playground delivered to Shell Cove Park, only to be put under tarp. The city did apply for a few more grants for a splash pad and Memorial Park. Councilman Kovach asks did we have any equipment breakdown with all this snow? Superintendent Hastings replies no breakdowns, but we did have a couple trucks get stuck. \*Motion by Kovach/Second by Erdei to accept the report. Yeas All.
