**MAYOR:** Mayor Bring has no report. /**SUPERINTENDENT:** Superintendent Hastings reports leaf season has started, and we have probably swept the city 4 times already. The plows are ready to go, and salt is ordered. The water/service dept. has been focusing on lead service lines which the EPA is requiring a lot of intervention, mapping, etc. Councilman Erdei asks how many lead sewer lines do we have? Superintendent Hastings replies they are lead water lines/joints. We treat the main system for that. The concern is the main service lines that go up to your house. Anytime there is something that might aggravate that lead line, the city is required to give a filtering system to the homeowner and in some cases, replace the lead line. We test for lead randomly and send reports to the EPA. Councilman Cizl asks they just approved the infrastructure funding for the federal, do you have any plans yet for what we are going to do? Superintendent Hastings replies I really need a framework of how you can apply for the money. /**FINANCE**
