NEW BUSINESS: Law Director Graves states virtually every local community has adopted ordinances prohibiting fireworks consistent with the language of the Ohio Revised Code (ORC) and Sheffield Lake is no exception. Our chapter 1519 mirrors the ORC former language in terms of the prohibition of the use of fireworks. In November of 2021, House Bill 172 was passed which allowed many consumer grade fireworks to be purchased and utilized in Ohio. Part of the language of House Bill 172 permitted local communities to opt out and continue to ban fireworks as they had historically. Many communities are electing to do that. It is up to us if we want to operate under the state code or if we want to opt out. Chairman Radeff says I think this is a better question for the full council. Member Cizl asks what is the motivation behind the state doing this? Mayor Bring replies sales. Law Director Graves says the statute has 10-12 holidays that you are allowed to do it, it is only certain days, not every day.
