**COUNCIL #035- SECOND READING-** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE CITY OF LORAIN FOR THE TRANSPORT, RECEIPT, TREATMENT AND DISPOSAL OF SANITARY SEWAGE ORIGINATING FROM THE CITY OF SHEFFIELD LAKE AND THE DECLARING OF AN EMERGENCY.

**COUNCIL #037- FIRST READING-** A RESOLUTION AUTHORIZING THE CITY OF SHEFFIELD LAKE TO ACCEPT AND APPROVE THE DONATION OF FUNDS FROM VFW POST NO. 8686 AND AMVETS ERIE POST NO. 55 FOR A MILITARY THEMED POLICE CRUISER WRAP FOR THE SHEFFIELD LAKE POLICE DEPARTMENT AND THE DECLARING OF AN EMERGENCY.

President Rosso asks I would like to know why the police want this and what the importance of it is. Mayor Bring replies I can get a comment from the chief for the next meeting. Councilman Kovach asks will that affect the use of this being a police vehicle with that wrap? Law Director Graves replies as long as the vehicle is properly identified as a Sheffield Lake police car, then it is valid for traffic enforcement. I don't see any problem with it being used. The quote you received was for \$2,900 with a \$300 discount for sponsorship. That was if we put CLE Signs on it, we said we are not advertising for profit businesses on public vehicles. So, we will not get that \$300 discount. The additional \$7,900 on the quote is for extras that we declined. Councilman Cizl says I would like to see a picture, is it patriotic or military like camouflage? Law Director Graves replies it is patriotic, it is basically a flag. I used the language from the quote which says military, but it is more patriotic.
