

Minutes of the Ordinance Committee meeting
Sheffield Lake, Ohio
July 5, 2022

This regular meeting of the Ordinance Committee was held Tuesday, July 5, 2022. Chairman Radeff called the meeting to order at 7:04 PM.

ROLL CALL OF MEMBERS:

MINUTES: June 7, 2022 *Motion by Wtulich/Second by Cizl to accept the minutes with any corrections. Yeas All.

PRESENTATIONS: None.

OLD BUSINESS: Chairman Radeff states I did get some of the ordinances the chief wanted for review and sent those out today. I know a couple had to do with guns. I am going to CLE for a municipal league at the end of the month and it will go over the new gun laws. Law Director Graves says I went through them and some of them are pretty straight forward. The old ordinance regarding spitting, we may want to repeal that. Park police, we don't have those. Just recommending some form of ordinance for excessive alarm calls and we can get some samples. Chairman Radeff asks what does that mean? Law Director Graves replies people have home security systems and they are tied to the police dept., some go off all the time for reasons like loose doors, animals, etc. and the police respond, and they are false alarms.

NEW BUSINESS: Member Cizl asks regarding council #037, it still says military and I think it's a little deceiving. It should say patriotic. Mayor Bring states Mr. Hastings and I had a meeting with Republic the other day and we discussed the refuse. One thing that came up is when people move out and they throw the whole contents of their house out. In talking to them, they didn't feel it should be Republic's responsibility, even though it's trash. We kind of agreed, because that can take up almost a whole truck. I think we should look into some type of ordinance where we could go after those people. Republic said they would offer a dumpster at a lower price for that. Chairman Radeff says are other cities doing it? I don't want to do it if we are going to be the only ones doing it. Law Director Graves says in Avon Lake it works where you can put bulk out any week you choose, but only one time a month. They keep a record. If you do it more than once a month, you get charged extra and it is limited to a certain size. Chairman Radeff says maybe people can

notify them ahead of time and we have a set price. Mayor Bring replies we would have to get a price of what a small dumpster would cost and add that to what the fine would be. Law Director Graves says we would have to amend the current agreement. It says unlimited, but we recommend no more than 4 items.

CITIZEN’S COMMENTARY: None.

ORDINANCE/RESOLUTIONS BEFORE COUNCIL AT THIS TIME:

COUNCIL #038-SECOND READING- AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING AMONG THE CITY OF AVON LAKE, THE CITY OF SHEFFIELD LAKE, AND THE VILLAGE OF SHEFFIELD, REGARDING SHARED JURISDICTIONAL AUTHORITY FOR ENFORCEMENT OF THE OHIO BUILDING CODE FOR PERMITTING AND INSPECTION OF IMPROVEMENTS AFFECTING STRUCTURES CONSTRUCTED OR TO BE CONSTRUCTED BY FORD MOTOR COMPANY WHICH ARE LOCATED IN MULTIPLE JURISDICTIONS AND DECLARING AN EMERGENCY.

Law Director Graves states there will be additional legislation forthcoming. We will have the agreement for the purchase of the street sweeper, one to advertise and enter into bids for the Ivanhoe repaving project, one for the annual bid including a proposed target road list and a resolution for the service director who is expressing his desire to retire and be rehired just like we did with the finance director.
