Member Cizl asks they were running some wiring at the boat launch today? Mayor Bring responds we are getting all new cameras. The gentleman at Amazing Finds came to us the other day and he has a dumpster back there and people have been jumping in it. Kids have been in there, two women taking things, etc. He asked if we could put a camera up there, but he doesn't have cable/internet service. We contacted the woodshop to see if they do and they are supposed to get back to us. We are going to add an additional 2 cameras over there to help. Law Director Graves states the two individuals were charged with criminal trespass.

E) ***CITIZENS COMMENTARY:*** Rick Schaffer, 635 Hollywood Ave. asks the comment about the solar panels, how much money does that save us? Mayor Bring replies to be honest, I don't know. It powers some stuff, but I don't know how much we are getting credit for. Mr. Schaffer asks are the solar costing us more than what we are getting from them? Mayor Bring replies I don't know. If you are looking at the amount of damage to the roof, I would say yes. Mr. Schaffer

says maybe it's not worth it to have them up there. Mayor Bring says that's what we are discussing. If we do take them down, we would probably put them up at one of the service dept. buildings or in the mechanic's building. We wouldn't throw them away.
