I continue to get quotes for the roof so my pricing is current as we continue to seek funding. Member DeBottis asks are there any plans to paint the inside of the community center? Service Director Hastings replies yes. Also, we installed a door, replaced a door on the side, replaced the hardware on the interior doors and our list will now focus on interior painting. Short discussion on tape/paint. Member Cizl asks with the remodeling we are doing, are there any goals of taking these mayor pictures and doing something to display the history? Service Director Hastings replies I have talked to the mayor and Rick about removing some of the couches, maybe another row of seating and maybe some half tables for presentations, etc. So, we have been talking about improvements, but as far as the pictures, I would wait for direction from the mayor. Mayor Radeff says we did get some extra from NOPEC and talked about doing some sort of screen up there too and it might be kind of smart to digitize them instead of putting them up and taking them down.
